

ONE ACCUSED PERSON CONVICTED WITH 5 YEARS RIGOROUS IMPRISONMENT FOR ABETMENT OF SUICIDE OF TRIMULGHERRY PS CASE

On 02.11.2021 the Honorable VI Addl. Metropolitan Sessions Judge, Secunderabad has pronounced the Judgment in Cr. No. 141/2014 U/s 306 IPC of PS Trimulgherry, North Zone, Hyderabad City.

DETAILS OF THE ARRESTED PERSONS:

Gujju Gheethakrishna S/o G. Venkat Reddy, age: 30 years, Occ: Student, R/o Sy.No.144, Voolapeta, sanghivalasa Village, Bheemili Mandal, Vishakapatnam Dist, A.P.

BRIEF FACTS:

The complainant Sri J. Venkat Ramana Reddy, S/o late Naryana Reddy, age: 47 yrs, Occ: SBH Security Department, R/o H.No. 129/21, Meghana Flats, Mallareddy Nagar, Lothkunta, Secunderabad. Stated that on 12-06-2014 at about 0300 hrs, his wife and relatives went to Shiridi after that his daughter by name Bhagya Sri Reddy, went to her bed room and he was sleeping in the hall, in the morning he wakeup at about 0800 hrs, he noticed that his daughter hanged herself to a fan with a saree in her bed room, immediately removed the saree with the help of his neighbor Mr. Srinivas Reddy and shifted her to Oxyzen Hospital, and the duty doctor declared that brought dead. In her life time she loved one Mr. Geetha Krishna and he also loved her. She asked about their marriage, he rejected to marry her due to that panic she committed suicide.

The Honourable VI Addl. Metropolitan Sessions Judge, Secunderabad has fixed the schedule and conducted trial. The Addl. Public Prosecutors: **Dr. K. Ajay & R. Upender** conducted prosecution and briefed the witnesses thoroughly about the case with the help of Court duty officer, Sri B. Ravinder Reddy PC 7183 of PS Trimulgherry. The efforts lead to successful prosecution of the case.

Sri Y. Sathyendra, Hon'ble Spl. Judge for trail of offences under S.Cs & S.Ts (POA) Act -cum- VI Addl. Metropolitan Sessions Judge, Secunderabad gave a verdict, wherein the accused person Gujju Gheethakrishna S/o G. Venkat Reddy, age: 30 years was found guilty for the offence U/s 306 IPC and he is convicted under section 235(2) CrPC with rigorous imprisonment for a period of five (5) years and fine of Rs.20,000/- (Rupees twenty thousand only).
