

**PD ACT INVOKED AGAINST MOHAMMED MUJEEB S/O MOHAMMED
MUNEER UDDIN, DRUG OFFENDER OF FALAKNUMA POLICE STATION,
HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City issued a preventive detention order under the Act No.1 of 1986 against Mohammed Mujeeb s/o Mohammed Muneer Uddin on 28.10.2021.

The detenu Mohammed Mujeeb s/o Mohammed Muneer Uddin, aged about 31 years, Occ: Accountant in Kamela, r/o H.No.18-13-9/72/B, Ghazi-e-Millat Colony, Chandrayangutta, Hyderabad was peddling Narcotic Drugs among the people **in the limits of Hyderabad Police Commissionerate** with his associates in an organized manner. He has developed widespread network, wherein he uses cell phones and other information technology devices to escape police observation.

He committed an offence in peddling of Narcotic Drugs among the people in the recent past and his illegal and highly dangerous activities in peddling of Narcotic Drugs among the people has been endangering the lives of youth and innocent people causing irreparable damage to the body organs including the Central Nervous System, thereby crippling the mental and physical health of the people addicted to drugs. His activities were prejudicial to the maintenance of public order and public health at large.

Falaknuma Police arrested the detenu Mohammed Mujeeb on 30.4.2021 in Cr.No.111/2021 u/s 8 (c) r/w 20 (b) of NDPS Act, 1985 of Falaknuma Police Station and remanded him to judicial custody. The preventive detention order was executed on him **on 29.10.2021** and he was lodged in Central Prison, Chanchalguda, Hyderabad.

Today (9th November,2021) Sri.Anjani Kumar IPS CP Hyderabad City and Sri.DS.Chauhan Addl. CP L&O/HQ has conducted an Inspection of (55) Innova Crysta (Patrol Cars) and (16) Scorpios (Interceptor vehicles) of Hyderabad City Police. Later CP Hyderabad addressed with gathering that drivers should maintain the standard operating system (i.e SURVEILLANCE OVER CRIMINALS, CRIME PREVENTION, VISIBLE POLICING THROUGH MOTORIZED FOOT PATROLLING, COMMUNITY POLICING, EMERGENCY RESPONSE, ANTI-DESECRATION DRILLS, BANDOBUST DUTIES) and explained as;

- Checking outside Criminal Gangs taking shelter Temporarily in the area
- Signing Point Books Identifying Crime Prone Areas from Crime Mapping Application from time to time and revising the Patrol Route Map
- Motorized and Foot Patrols in Crime Prone Areas as per Latest Crime Occurrence Timings
- Temporary Halt at Crime Hot Spots and organizing Foot Patrol in 200 yards in the vicinity of Crime Hot Spots
- Questioning and Physical Frisking of Strangers in Crime Hot Spot Areas while on Foot Patrol
- Visible Patrolling at odd hours to create a Sense of Safety and Security in the General Public especially Women, Children
- Organising Crime Awareness Programmes in Community Groups
- Identifying Policing Needs of the Areas/Community Groups
- Constant Interaction with Community on Crime, Criminals, Criminal Intelligence, Criminal Surveillance, etc., Receiving all Emergency Calls from Dial 100, PS, and Local Public, etc.
- Responding to all Emergency Calls within the Shortest Possible Time etc .

And also said that vehicle driver to avoid accidents and proper maintenance of vehicles. And CP Hyderabad gave mementos to 6 Police personnel for their good performance and maintain the vehicle.

Sri.Babu Rao, DCP CAR Hqtrs, Sri.Mohd.Burhan Ali, Addl.DCP (MT & Stores), Sri.K.Shyam Sundar Addl.DCP, Sri.B.Kistaiah, Addl.DCP and Sri.M.Suresh RI MTO-1 and Sri.Mohd Sarwar Ahmed RI MTO-II, CAR Hqrs, Hyd., were present during the inspection program.

Today i.e., on 09-11-2021 Hyderabad Traffic Police has filed 32 charge sheets of Panjagutta Tr. PS against the persons who were caught while driving their vehicles in drunken condition and produced them before the Hon'ble IV Metropolitan Magistrate Court, Nampally, Hyd.

The Hon'ble IV MM Court has awarded the following punishment for the violators.

- 1) For **29** persons punishment was given with a fine of Rs. 10,500/- who were caught **for 1st time** while driving vehicle in drunken condition.
- 2) For **2** persons punishment was given with a fine of Rs. 16,500/- and cancelled their driving license permanently, who were caught **for 2nd time** while driving vehicle in drunken condition.
- 3) For **1** person punishment was given with a fine of Rs. 16,500/- , cancelled his driving license permanently and sent to Chanchalguda Jail for 12 days, who was caught **for 3rd time** while driving vehicle in drunken condition.

Hyderabad Traffic Police, requests the citizens to not to drive their vehicles in drunken condition and also it is informed that the respondents who were convicted in drunken drive may face difficulties in getting govt. jobs, passport and visa clearance.

The CCS Police arrested the accused Pediripati Shekar Goud age. 38 yrs, Occ: Real Estate business and Managing Partner of 5 TV Networks, 5 TV News Channel, Shamshabad, Ranga Reddy District is doing real estate business and specially dealing with disputed lands.

The accused Pediripati Shekar Goud is the native of Thondupally village of Shamshabad. The accused Pediripati Shekar Goud colluded with another accused hatched a plan to earn money in easy way. They prepared a fake and forged agreement of sale of open plot of 1500 square yards of a Pvt Company at Moosapet village for implementation of their plan with common intention both the accused approached the complainant, a business man, r/o Banjara Hills, Hyderabad offered the open plot for sale for Rs. 11.25 crores and lured. Believing them, the complainant paid an amount of total Rs. 1,10,00,000/- as advance. On the complaint of businessman the case was registered at CCS and is under investigation.

To protect their business P. Shekar Goud, A-1 and his wife Saritha executed a partnership deed in the month of April 2019 established T.V Network, 5 TV News channel entertainment on the name of M/s Vinayaka Broad Casting Networks.

The accused Pediripati Shekar Goud was arrested on 08-11-2021 by Team-X of CCS, DD, Hyderabad and being produced before the Hon'ble Court for judicial remand.

The case is investigating by Sri B. Srinivasa Rao, Asst. Commissioner of Police, WCO Team-X, CCS under the supervision of Sri N. Mahender, Addl. DCP, EOW, CCS.

He is the most active Rowdy Sheeter of KAMATIPURA P.S. and operates in Hyderabad & Cyberabad Commissionerates and previously the Rowdy Sheeter THAKUR DEEPAK SINGH BADEKAR @ DEEPAK was involved in (06) cases viz. Murder case , Arson cases, Extortion cases at various police stations of Hyderabad and Cyberabad Commissionerates.

On 08-11-2021 at 1500 hrs the rowdy sheeter THAKUR DEEPAK SINGH BADEKAR @ DEEPAK was arrested and lodged in Central Prison, Chanchalguda, Hyderabad for a period of one year under the Preventive Detention Act..
