

**ARREST OF ACCUSED IN ILLEGAL SALE OF BANNED (MDMA)
PSYCHOTROPIC SUBSTANCES PILLS**

It is a case of illegal sale of banned MethylenedioxyMethamphetamine (MDMA) Pills also known as Ecstasy/Molly registered on 11-11-2021 which occurred at Mehdiapatnam Bus Stop situated under the limits of Asifnagar PS of West Zone.

Brief Facts:

Today i.e on 11-11-2021, Inspector of police, Asifnagar Police Station received a credible information that some persons are indulging in sale of banned psychotropic substance drug at Mehdiapatnam Bus Stop. Immediately Inspector of Police deputed a team lead by Addl Inspector of Police to apprehended two persons namely **Belly Ajay Sai** and **Ankith** and seized psychotropic substance **MethylenedioxyMethamphetamine (MDMA) (50) Pills** and on their confessing another 60 Pills were seized from Dharawath **Sai Charan** all worth Rs. 3 Lakhs. The accused purchase the banned pills for a price of Rs.1500/- each pill and sell each pill to the consumer for a price of Rs. 2500/- and above.

M.O. :-

The accused purchase the banned drugs and distribute to the customers through mobile apps. Advance payment through mobile apps has to be made for procurement of the Pills.

Press Note on Seizure of 14.2 kg Pseudoephedrine on 11th November 2021 in PS Begumpet Limits of Hyderabad Commissionerate

- The sleuths of Begumpet Police Station and Directorate of Revenue Intelligence, Hyderabad acting on specific intelligence that certain NDPS substances are being concealed in parcels destined to Australia, two parcels were interdicted at an International Courier Agency in Begumpet PS limits of Hyderabad Commissionerate on 09.11.2021.
- The parcel boxes contained photo frames and other products. On careful examination of the Photo frames in the consignments revealed plastic cover containing white powder like substance sandwiched between the 2 layers of the photo frame. This substance tested positive for Pseudoephedrine, a controlled substance under the NDPS Act 1985.
- A total of 22 such photo frames have been found in these 2 parcels, with each parcel containing 11 photo frames. The total quantity of 14.2 kg of pseudoephedrine has been retrieved from these photo frames.
- Preliminary investigations revealed that the consignments were booked using fraudulent Aadhar card having Hyderabad address by two persons, possibly from Tamil Nadu. Further investigations are underway.
- The black market value of this drug is around INR 40 Lakhs. The total worth of this seizure is around approximately INR 5.5 crores.
- This is in continuation to a series of more than 15 cases involving 300+ kg of ephedrine and pseudo ephedrine consignments destined to Australia by courier, air and sea cargo, detected by DRI Hyderabad in the past one year at various locations including Chennai, Delhi and Bengaluru.
- The task was done in the supervision of Sri Kalmeshwar Shingenavar, DCP North Zone and the team consisted of Sri Naresh Reddy, ACP Begumpet; Sri P Srinivas, SHO Begumpet; Smt Deobara, Detective Inspector Begumpet, Sri Muthyam Raju and Sri L Suresh, SIs Begumpet, Sri Srinivas, PC and Sri Sai Kumar, PC of PS Begumpet.
