

**NALLAKUNTA POLICE ARRESTED (1) GOLD CHAIN SNATCHING
OFFENDER AND RECOVERED 13.7 GRAMS GOLD CHAIN WITH LAXMI
DEVI LOCKET WORTH RS.60, 000 IN CR.NO. 326/2021 U/S 392 IPC OF
NALLAKUNTA PS**

On 05/01/2022 the Nallakunta Police apprehended 1 gold Chain Snatching offender at his residence Nagamaiah Kunta, Nallakunta and recovered 13.7 grams gold chain with Laxmi Devi locket.

DETAILS OF ACCUSED PERSON:-

Accused Person:- Vaddy Shiva S/o Yellaiah, Age: 26yrs (DOB:-13.08.1995), Caste:- SC, Occ: Sand Worker at Ram Nagar, R/o H.No:- 1-9-1113/27/F/292, Nagamaiahkunta, CCS office, Musheerabad, Hyderabad.

BRIEF HISTORY OF THE ACCUSED:

The accused person hails from Hyderabad. Accused person working as a Sand Worker at Ram Nagar. The accused person addicted to bad habits like Smoking and consuming alcohol. As his meager earnings are not sufficient to maintain his lavish life, accused person hatched a plan to commit snatching of gold chain to earn money easily by selling the gold chain to others.

MODUS OPERANDI:

The accused person robbed the gold chain from the neck of complainant who was going by walk by travelling on the Honda Passion Plus two wheeler Br No AP 11 Q 8681, on road side in the evening hour and sold to unknown persons to earn easy money to fulfill his dire needs and the money spent for his lavish expenses.

On 05-01-2022 at 0810hrs apprehended the accused person information given by the owner of the vehicle Pullolla Kashinath Goud and the accused person was apprehended at his residence Nagamaiah kunta, Nallakunta. After recording the confessional statement and seized the stolen property on 05-01-2022 at 1105hrs and Two wheeler Hero Honda Passion Plus Br No AP 11 Q 8681 (Used to Commission of offence) and being produced him before the Hon'ble IV ACMM Court for judicial custody.

The case was investigated by DI Sri. D Kishan with the assistance of Crime staff under the supervision of Sri. Mogilicharla Ravi, Inspector of Police, Nallakunta PS under the able guidance of Sri. HELD TWO PERSONS –BUSTED ADULTRATED VIJAYA GHEE SUPPLY ROCKET**SEIZED 970 LITERS OF ADULTRATED GHEE.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Vijaya Dairy Development officials and Shahinayathgunj Police conducted joint operation at New Famous Transport, Jummerath Bazar and apprehended two persons by name Deepak Penurkar and Rahul Agarwal and **seized 970 Liters Adulterated Ghee and Holograms of Vijaya dairy Products Total Worth of Rs.5 Lakhs.**

Brief facts of the accused.

The accused Deepak Penurkar leading his life with his family members at Siadabad and he is running OYO lodge at Saidabad. Due to pandemic and lock down the business is not running well. He hatched a plan and met with his distance relative Rahul Agarwal who is familiar with oil and ghee business. On the direction of Rahul Agarwal, Deepak established own manufacturing unit at his native place at Nanded and started production of adulterated Ghee with Palmolin and vegetable fats. The same has been repacked in the Poly-Packs which are designed as Vijaya Telangana Brand. Later the adulterated Ghee sending to Rahul through transport for further sale to the customers.

Basing on credible information, the South Zone Task Force, Hyderabad along with Vijaya Telangana State Dairy Authority officials and Shahinayathgunj Police apprehended the above two accused and recovered Adulterated Ghee. The apprehended accused and seized material handed over to **SHO Shahinayathgunj** Police for taking further action.
