Hyderabad CP Sri.CV Anand made a detailed visit and review of the Police Command Control Centre coming up in Banjara Hills. This 20 floored structure is coming up as a crisis management center too, apart from operating as a command control center and CP Hyd City office .He was received by Sri VAK Padmanabha Rao, Superintendent Engineer R&B and his team along with contractor Shapoorji vallabhjee company representatives .They explained on maps the entire plan of the 4 towered building and the 20 floors. Later they physically inspected all the floors of the building starting from the security areas, parking in two floors, the meeting halls and auditoriums ,the CP Hyd office and those of all the wings of city police, the emergency floors and rooms of the Hon'ble CM, CS ,DGP etc ,the data center, the command control center, the spaces for other agencies etc

Later a PPT presentation was given on the progress of works and the pending ones. The CP Hyd enquired and found out the various reasons for delay in the completion of the project. It was decided to have a meeting with the various vendors engaged by the agency for execution of various aspects of the projects and pressurize them to complete works as per schedule. Mr Anand exhorted them to work cohesively and offers the full cooperation of city police to R and B and Pallonji. He asked them to keep the building ready for inauguration by the Honorable CM by March 31 st .

Sri CV Anand said that the Command Control Center will be the third eye for the city of Hyderabad in the near future, the first of its kind in the country and the only such Command Control Center in Singapore and New York.

Relevant engineers, Sri. Joel Davis, IPS, DCP West Zone, Smt Sunita Reddy, DCP Admin, and other officials were present on the occasion.

**APPREHENDED ONE PERSON WHO IS IN POSSESSION OF
PROHIBITED CHEWING TOBACCO PRODUCTS & BANNED
FOREIGN CIGARETTES SEZIED FIVE LAKHS WORTH
MATERIAL BY CENTRAL ZONE TASK FORCE TEAM,
HYDERABAD**

On 12-01-2021, on credible information the sleuths of Commissioner's Task Force, Central Zone team, Hyderabad raid one godown situated at #16-8-705, Shoaib ground, New Malakpet, Hyderabad apprehended one accused person and seized prohibited chewing Tobacco products & banned foreign cigarettes total worth of about Rupees Five Lakhs.

Brief facts of the case:

The brief facts of the case are that Md. Abdul Rauf @ Rahan who is in Pan Masala Business hatched a plan to supply and sell the prohibited chewing Tobacco

products & Banned Foreign Cigarettes as there is Huge demand for Tobacco products which were banned by the Government of Telangana. He accordingly to his plan dumped the prohibited chewing Tobacco products & banned foreign cigarettes in his godown which were procured from Karnataka State and selling them to the needy customers and Pan Shop vendors secretly for huge amount and gaining illegal profits as sale of Tobacco Products is prohibited in Telangana.

Today while Md. Abdul Rauf @ Rahan while selling the prohibited chewing Tobacco products & banned foreign cigarettes products the Central Zone Team raided the godown and seized prohibited chewing Tobacco products & Banned Foreign cigarettes total worth of about Rupees Five Lakhs from his possession.

The apprehended accused along with seized material were handed over to SHO, Chadarghat Police Station for further necessary action.

FACTS OF THE CASE:

On the credible information about the supplying of drugs the SI Sri E. Saidulu and his team have apprehended the accused persons A-4 to A-7 with (04) MDMA Pills from A-4 and (01) Hash Oil from A-5 & (01) Hash oil from A-6 near Anwar Ul Uloom Degree College, Mallepally, Hyderabad and after recording the confessional cum seizure panchama by the Inspector of Police, Habeebnagar the A-4 confesses Six more accused persons who are consuming the drugs and supplying to the A-4 as well as selling to the needy customers. The A-9 has confessed one more supplier accused as A-3 and the Accused A-8 has also confessed one more supplier accused as A-2.

In this case the accused persons A-1 to A-3 are the main supplier of durgs were absconding and the Accused persons A4 to A-12 were arrested along with (04) MDMA Pills & (08) Hash Oil and remanded them to Judicial custody.

MODUS OPERANDI:

As per the confession statement of the accused persons, it is revealed that the accused persons A-4, A-05, A-06 & A-11 were born and brought up in Hyderabad and went to Saudi Arabia for higher studies, subsequently they return back and living in Hyderabad. Due to friendship from the Saudi Arabia they hatched a plan to earn money in a easy way within a short period. They started selling the drugs by procuring from the A-1 to A-3 for consuming and as well as selling them to needy customers and earning the money.

Today i.e. on 12-01-2022 in the morning hours the (9) Accused were apprehended by the Habeebnagar Police along with DCP West Zone team under the supervision of Sri D. Joel Davis, IPS, DCP, West Zone, Hyderabad, & Sri Siddiqui, Addl. DCP West Zone, Hyderabad.

NABBED THREE ACCUSED PERSONS FOR ILLEGAL PROCURING, STOCKING, SALE AND USE OF BANNED MANJA (NYLON THREAD) AND GLASS-COATED MANJA FOR KITE FLYING.

On 11 & 12-01-2022 on credible information the sleuths of Commissioner's Task Force, Central Zone Team conducted raids in Mangalhat, Shahinayathgunj & Begumbazar limits and apprehended three accused who are running Kites shop and illegally procured, stocked and selling banned Manja (Nylon thread and glass coated manja for kites flying) which is harmful to animals including human beings to gain easy money illegally. The accused violated the orders of Environment, Forests, Science & Technology (Env) Department, Hyderabad.

FACT OF THE CASE :-

The accused person T Pavan Singh residing at H.No.14-10-1452, Jali Hanuman Temple, Dhoolpet and running Kites business in his residence, the accused Mahaveer Prasad resident of Begumbazar running kites business in "Sree Balaji Rakhi Bhandar" Situated at Bartan Bazar, Feelkhana, Begumbazar and the accused Yonith Goel resident of Kachiguda running kites business in "Bajaj Kites" Situated at Tez Towers, Jain Mandir Road, Feel Khana, Begumbazar. In the traditional Sankranthi festival they used to sell Kites and Manja of various brands, they used to manufacture Kites of various models used to delivery to known and needy customers on wholesale price. Their income is not sufficient to do the business; hence they hatched a plan to sell the banned "Nylon Manja Dors" which is very demand during the Sankranthi Festival for use in the in the Kites festival to gain easy profits illegally.

The accused persons know the dangerous effects of Chines Dor, but also illegal procured, stocked and selling synthetic threads coated with glass or other harmful substances for kite flying or other purposes and likely to cause grievous injury and inconvenience to animals including birds as well as human beings during festivals or other occasions.

ARREST :-

On 11 & 12-01-2022 on tip of the Commissioner's Task Force Central Zone team conducted raids on H.No.14-10-1452, Jali Hanuman Temple, Dhoolpet (Mangalhat Limits), Sree Balaji Rakhi Bhandar (Shahinayathgunj limits) and Bajaj Kites (Begumbazar PS) and apprehended above three accused persons.

Seized Synthetic nylon Big Size Babin's -198, Medium Size Babin's -84 & Small Size Babin's – 230 from the instance of three accused persons in the said shops. Seized material market worth about Rs. 1,50,000/-

The apprehended accused person along with seized material were handed over to SHO, Mangalhat PS, Shahinayathgunj PS & Begumbazar PS for further necessary legal action against them as per law U/Sec. U/s 336 IPC and sec 5 & 15 of Environmental protection Act-1986.
