

**PRESS NOTE****APPREHENDED (01) DRUG PEDDLER - SEIZED - 30GRAMS OF MDMA, 01 MOBILE PHONE AND CASH Rs. 3000/- . - ALL WORTH OF Rs.5 LAKHS/-**

The sleuths of the Hyderabad Narcotic Enforcement Wing (H-NEW) along with Golconda Police apprehended **(01)** Drug Peddler. Who was found in illegal possession of Narcotic Drugs i.e., MDMA near Ramdevguda, under Golconda PS limits, Hyderabad. **Total 30 Grams of MDMA, (01) Cell Phone and Cash Rs. 3000/-** are Seized at the instance of the accused.

**BRIEF ABOUT ACCUSED:**

The accused Mohd. Alim Khan is native of Uttar Pradesh State and living in Tanvel Locality in Mumbai City for the last 4 years, where he has developed contacts with Drug Dealers and Purchase Psychotropic drugs from dealers and Supplying to the needy Consumers in Mumbai and Hyderabad. Frequently he visits Hyderabad city and supply drugs i.e., MDMA to needy customers at price of Rs. 15,000/- per gram.

On credible information on 21.10.2022, when the drug peddler i.e., **Mohd Alim Khan** when he has come to Hyderabad and was trying to sell the drugs at Ramdevguda, under Golconda PS limits, Hyderabad to drug consumers, the Hyderabad Narcotic Enforcement Wing (H-NEW) along with Golconda PS apprehended the drug peddler and Seized 30 grams of MDMA (Psychotropic Substance) from his possession.

As of now (11) Drug Consumers, who are purchasing drugs from the above accused are identified and the investigation is being continued to identify other consumers.

**APPEAL TO THE GENERAL PUBLIC: -**

In recent times we have seen several youth/students getting addicted to Drugs, committing crime and involving in other anti-social activities. Several families have become victims of this menace. **APPREHENDED (01) FOREIGN NATIONAL DRUG PEDDLER BELONGING TO NIGERIAN COUNTRY AND (02) INTERSTATE DRUG PEDDLERS - SEIZED – 40 GRAMS OF COCAINE, (08) CELL PHONES – ALL WORTH OF Rs.5 LAKHS/-**

The sleuths of the Hyderabad Narcotic Enforcement Wing (H-NEW) along with Panjagutta Police apprehended (01) Foreign National Drug Peddler and (02) Interstate Drug Peddlers. The peddlers were found selling and possession of Narcotic Drug i.e., Cocaine. Total seized 40 Grams of Cocaine and (08) Cell Phones at the instance of the accused persons.

## BRIEF ABOUT ACCUSED:

The Foreign National i.e., Mohammed Toiru Bakari who was absconding in Cr.No.557/2022 of NDPS Act of Panjagutta PS, belonging to Nigerian Country (Africa) and residing illegally in Pune. On enquiry, it has come to know that, in the year 2013 he came to Mumbai, India on tourist visa. He used to work as a Chef at an African Restaurant at Mira Road Mumbai. During the said time he met with drug suppliers at the said restaurant and started procuring the drug in small quantity and selling the same to the customers. As the demand of Cocaine in Pune is high and to earn easy money, in the year 2017 he moved to Pune and started doing Drug peddling. In the year 2019 he along with Apurva Mataprasad Upadhyay were arrested by the Narcotics Cell, Customs, Pune in Cr. No.13/2019 for selling and possessing 40 grams of Cocaine and was released in 2020.

Since then, they both continued the drug peddling business to the needy consumers of Pune, Mumbai, Hyderabad. For the past 5 years they are doing this drug peddling. He frequently visits Hyderabad to sell the Narcotic Drug i.e., Cocaine to the needy consumers and also supplies the same to the Drug Peddlers namely 1) Apurva Mataprasad Upadhyay and 2) Ajay Kumar Choupal to earn easy money.

As of now (05) Drug Consumers, who are purchasing the drug from the above accused are identified and the investigation is being continued to identify other consumers.

On thorough interrogation, the Hyderabad Narcotic Enforcement Wing (H-NEW) along with Panjagutta Police unearthed 40 grams of Cocaine from the possession of 3 accused persons and 8 Cell Phones.

Further, the seized material handed over to SHO, Panjagutta Police Station, Hyderabad for further investigation in the above case.

**Place of offence** :- Sabeel Pan Shop, Bibi Bazar X Roads

**Nature of Offence:-** Attempt to extortion with county made weapon/Air Gun by threatening with dire consequence to kill.

**Brief of the case:-**

One unknown person came to Sabeel pan shop at Bibi Bazar X Roads belong to Sri. Mohammed Fahaad Khan, S/o. Mohammed Rahman, age: 24 yrs, Occ: Pan Shop, R/o. H.No.18-8-536/A/2, Kumar Wadi, Edi bazaar, Hyderabad. taken 3 Cigarettes for that he give only Rs.10/- then the complaint asked the remaining amount which is 3 Cigarettes cost is Rs. 21/- but he denied to give remaining amount and then the unknown person threaten with dire consequence to kill. and tried to attack with air gun.

The complaint received on 22-10-2022 and a case was registered in Cr.No.167/2022. U/s 384, 506, 323 r/w 511 IPC. Immediately Sri G Prasada Rao Asst commissioner of Police Mirchowk Division, form a team nab the un known person. Detective Inspector Sri. K Gurunath, Sri T. Vinod SI of Police, , Sri B. Raghavenra Rao PC 30307 & K. Vijay Kumar PC 8638 of PS Moghalpura apprehended the accused by verifying the CCTV footages within one hour.

**Accused Details:-** Mohammed Wajeed Uddin @Wajeed S/o Mohammed Hameed Uddin, Age:27 years, Occ: Rapido, presently residing at near Nizam Hotel, Aman Nagar A, Bhavani Nagar, Hyderabad and Aadhar Address: R/o H.No.18-7-299/42, Aman Nagar A, Moula ka Chilla, Yakutpura, Hyderabad. He was arrested and send to Judicial remand.
