On credible information the sleuths of Commissioner's Task Force, North Zone Team, Hyderabad along with Police Marredpally conducted raid at organized betting gaming house situated at H.No. 1-76, Railway Colony, West Marredpally, Hyderabad and apprehended (04) Cricket betting bookies/Punters by name in the limits of Marredpally PS and apprehended **(04) Accused persons 1) Ajit Deshpande (Main Bookie), 2) Sandeep Kulkarni (Punter) 3) Mayur Joshi (Punter), 4) M.Suresh (Punter)**, while organizing & accepting betting amount from punters for ongoing 'T-20 World Cup' Cricket match and gain easy money illegally.

➤ **BRIEF FACTS OF THE CASE:-**

The accused Ajit Deshpande is resident of H.No. 1-76, Railway Colony, West Marredpally, Hyderabad. He earlier worked in MNC company and now he doesn't have to do works. So he attacked to Cricket Betting Activities for gaining easy money. Now T-20 World Cup is going on, so he started cricket betting and accepting amounts from his known punters through his cell phone. On 24-10-2022 when he has been accepting betting for T-20 match between South Africa Vs Zimbabwe match at his house, he along with above punters apprehended and seized betting amounts and cell phones.

The apprehended accused persons along with seized material were handed over to SHO Marredpally PS for taking necessary action.
