**APPREHENDED (01) GANJA PEDDLER - SEIZED 08 KGs OF GANJA –**

**ALL W.Rs. 1.6 LAKHS.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Chatrinaka Police apprehended (01) Ganja Peddler who is procuring and selling ganja illegally. **Total seized 08 KGs of Ganja** at the instance of the accused.

**DETAILS OF THE ACCUSED:-**

- 1) **Vallaboju Srinivasa Chary, @ Sampath**, age 34 yrs, Occ: Samosa Business, R/o Uppuguda, Hyderabad.
- 2) **Siddu**, R/o Narsipatnam, AP., ( **Absconding** )

**SEIZED:-**

- **08 KGs of Ganja.**

**BRIEF FACTS:-**

The accused person **V. Srinivasa Chary** is born and brought up from Hyderabad. He studied up to 7<sup>th</sup> standard. Previously he involved in more than 25 property offences. He leads his family by selling Samosa in trains from Secunderabad to Visakhapatnam. His earnings are not sufficient to meet his family expenses. Meanwhile, he noticed the demand of Narcotic Substances i.e. Ganja etc., in Hyderabad and surrounding areas. Upon which he hatched a plan to procure and sale the Ganja to the needy customers in Hyderabad and its surrounding areas to earn easy money. In this juncture, few days ago he came into contact with one person by name **Siddu, R/o Narsipatnam, A.P.**, who used to supply the Ganja to the needy customers in wholesale and retail. Subsequently, **Srinivasa Chary** started purchasing Ganja from **Siddu** him in low rate and the same is being brought to Hyderabad through train and selling the same to the needy customers and earning easy money illegally.

Recently, in the month of April 2022 he arrested in **Cr. No. 100/2022**, U/s 27, 8(C) & 20 (b)(ii)(A) of NDPS Act 1985 of Santosh Nagar PS and remanded to judicial custody. Later, he released from jail on 09/05/2022. After releasing from jail he did not mend his attitude and continuously procuring and selling Ganja illegally.

On credible information, the Commissioner's Task Force, South Zone Team along with Chatrinaka Police, Hyderabad apprehended the accused person and seized **(08) KGs of Ganja** at the instance of the accused. The apprehended accused and seized Ganja handed over to **SHO, Chatrinaka PS** for further investigation.

**APPEAL TO THE GENERAL PUBLIC:-**

In recent times we have seen several youth/students are addicted to Ganja/Drugs, engaged in crime and other anti-social activities. Several families have become victims of this menace. It is an ardent request from Hyderabad City Police to the youth/students not to fall prey to drugs and request the parents to keep a watch on the activities of their children and feel free to approach police or pass information to Police to curtail such anti-social activities and strive for Drug free city.
