Due to which he addicted to E-Cigarettes and there he hatched a plan to sell the banned E Cigarettes to the needy customers in high rates in order to get more benefits. Accordingly he came in contact with some persons who are n/o Mumbai City and he arranged E-Cigarettes through Courier from Mumbai. Later, said Salman collects the banned E-Cigarettes and runs a shop by name & style as **The Smoke Bar** at Banjara Hills, Road no:12, Hyderabad and started to sell the same to the customers and earning easy money. Further, it came to know that, E-cigarettes produce a number of dangerous chemicals including Acetaldehyde, Acrolein, and Formaldehyde. These Aldehydes can cause lung disease, as well as Cardiovascular (Heart) disease.

On tip-off information, the Commissioner's Task Force, South Zone Team along with Banjara Hills Police conducted raid at **The Smoke Bar** situated at Road no: 12, Banjara Hills, Hyderabad and apprehended the accused and seized banned E-Cigarettes. The apprehended accused person along with seized material handed over to SHO, Banjara Hills Police for further investigation.
