### **WEST ZONE TASK FORCE RAIDED ONE PARLOUR – TWO HELD SEIZED HUGE STOCKPILE OF HUKKAH POTS, DIFFERENT TYPES OF HUKKAH FLAVORS, COALS, FILTERS, PIPES, HEATERS**

On 13-05-2023 the Commissioner's Task Force, West Zone team along with staff, on credible information raided Parlor Styled as "**THE SHEESHA FACTORY CAFÉ**" located at QM Banquet Hall, 2<sup>nd</sup> Floor, Kakatiya Nagra, Tolichowki, Hyderabad and apprehended (02) persons who were illegally running Hookah Parlor at above said premises without valid license and severing to needy customer.

#### **Particulars of the Accused Persons:**

- 1) Syed Arshad Hussaini, S/o Syed Sajid Hussaini, Age: 25 Years, Occ: Owner of hookah parlor (THE SHEESH FACTORY CAFÉ). R/o. Backside of Fathima, Hospital, Kalapathar, Hyderabad.
- 2) Syed Obaid Hussaini S/o Syed Sajid Hussaini, Age: 21 Years, Occ: Owner of hookah parlor (THE SHEESH FACTORY CAFÉ), R/o. Backside of Fathima, Hospital, Kalapathar, Hyderabad.

#### **Details of the case:**

On enquiry, Syed Arshad Hussaini revealed that, Syed Arshad Hussaini & Syed Obaid Hussaini both are own brothers and they decided to earn easy money by providing Hookah to know/unknown customers, both brothers are having knowledge in mixing Hookah and they providing the same to customer at "**THE SHEESHA FACTORY CAFÉ**" located at QM Banquet Hall, 2<sup>nd</sup> Floor, Kakatiya Nagra, Tolichowki, Hyderabad. It is also found that they were dumped huge quantity of coals and other Hookah items which are highly flammable in nature and could result in fire accidents, as there are no safety precautions taken. Hence, Syed Arshad Hussaini & Syed Obaid Hussaini are violating the guidelines under COTP Act & Hyderabad City Police Act.

Hence above said accused persons and seized material handing over to SHO Langarhouse PS for further action.

The above arrests were made under the supervision of **Sri. P.
