SHE TEAMS

**1] Respondent threatened the petitioner to leave the flat by abusing in filthy language.**

Victim complained SHE Team through Gmail stated that, she residing in apartment at Srinagar colony and respondent V. Ramchandru, S/o. V. Muttaiah, age 53 yrs, Occ: Watchman, R/o. Srinagar Colony, Panjagutta working as Watchman in same apartment and frequently he harasses the petitioner and also threatening the petitioner that he will file a false SC/ST case if she ask Water. On enquiry, many complaints filed between the apartment members and complainant due to misunderstandings. The respondent misbehaved, threatened the petitioner and also asked her old aged mother to leave the flat. Simultaneously, SHE Team produced him before Hon'ble X Spl MM, Hyderabad, he was sentenced (8) days Jail and sent to Chanchalguda Jail.

**2] Respondent is married person and trapped the petitioner by maintaining physical relation**

Victim approached SHE Team through Whatsapp stated that, respondent M. Anjaneyulu @ Raju, S/o. M Rukaya, age 37 yrs, Occ: Pvt. Job, R/o. Wombay Colony, Nandanavanam, LB Nagar got acquaintance with petitioner through Snapchat. He trapped the petitioner by maintaining physical relation since five years. Later, the complainant came to know that he is already married and having three children. By hiding this, he maintained relation with petitioner and cheated her. Simultaneously, SHE Team produced him before Hon'ble XI Spl MM, Hyderabad, he was sentenced (5) days Jail and sent to Chanchalguda Jail.

**3] Petitioner being harassed by respondent over phone and threatened to dismantle her family.**

Victim approached SHE Team through whatsapp stated that, respondent V Rajkiran, S/o. Late Venkatesh, age 32 yrs, Occ: Driver, R/o. Uday Nagar, Banjara Hills previously who was petitioner's tenant. Due to his misbehaviour she asked him to vacate the room in the year 2022. Keeping this grudge upon the petitioner, the respondent harassed her over phone, threatened to dismantle her family. He also spread false rumours about her character that he had illegal affair with him. SHE Team produced him before Hon'ble XI Spl MM, Hyderabad, he was sentenced (5) days Jail and sent to Chanchalguda Jail.

**4] Respondent drove his Car rashly and abused in filthy language to the petitioner's wife who were driving two wheeler.**

Petitioner complained SHE Team through Gmail stated that, he and his wife were on two wheeler, respondent Mohd Shaibazouddin, s/o Mohd Moinuddin, age 23 yrs, Occ: Car driver, R/o. Godavari road, Luxettipet, Adilabad drove his Car rashly and scolded the petitioner's wife in abusive language. Respondent Produced before Hon'ble X Spl MM, Hyderabad, he was sentenced (8) days Jail and sent to Chanchalguda Jail.

**5] Respondent frequently calling the petitioner, abusing filthy language and sending nude videos.**

Petitioner approached SHE Teams directly stated that, she received phone calls from unknown numbers in midnight hours by sending nude videos and also abuses in filthy language. After that, she blocked those numbers. But again the respondent K Murali, s/o M Krishnappa, age 32 yrs, occ: Store Manager, R/o. Srinivas Nivasam, Siddivinayaka Layout, Madhapur N/o. Bangalore did not change his behaviour, called the petitioner from other different numbers and sent nude videos. Respondent Produced before Hon'ble X Spl MM, Hyderabad, he was sentenced (8) days Jail and sent to Chanchalguda Jail.
