**TRAFFIC ADVISORY**

In connection with **ELECTRIC VEHICLE RALL-E**, which will start from People's Plaza on the Necklace Road, Hyderabad and ends at HITEX Convention Center, at Cyberabad limits via Jubilee Hills Road No. 45 Cable Bridge the following restrictions and diversions will be **imposed from 1400 hours to 1730 hours on 05-02-2023 in the limits of Hyderabad City** on need basis.

**ROUTE OF ELECTRIC VEHICLE RALL-E RUN:**

People's Plaza (Necklace Road) – IMAX Necklace Road Rotary – VV Statue, Khairtabad – KCP Junction- Panjagutta – NFCL – SNT Junction – Sagar Society – KBR Park – Jubilee Hills Checkpost – Road No.45 – Cable Bridge enter into Cyberabad limits.

**DIVERSION POINTS**

1.	Traffic coming from Nallagutta Junction will not be allowed towards Imax Necklace rotary and diverted towards Ranigunj and Buddha Bhavan.
2.	Traffic coming from Telugu Thalli/ BRK Bhavana necklace rotary will not be allowed when the rally about to reach rotary and diverted toward Iqbal Minar.
3.	Traffic coming from Shadan/Rajbhavan Road (Somajiguda road) towards Panjagutta will be stopped for few minutes to allow rally to cross VV Statue junction.
4.	Traffic coming from Taj Krishna towards KCP will be stopped for a while at Mercure Hotel until rally passes KCP Junction.
5.	Traffic Coming from Monappa Island and intending to go towards NFCL will be stopped for few minutes until rally passes Panjagutta Junction.
6.	Traffic coming from Road No. 01 and intending to go towards Panjagutta junction will be stopped for a while until rally passes NFCL junction.
7.	Traffic coming from SNT/ Sagar Society and intending to take right turn will be stopped at NFCL until rally passes NFCL Junction.
8.	Traffic coming from SNT/ Sagar Society and intending to go towards KBR park will be stopped for a while until rally crosses KBR Park.
9.	Traffic coming from Cancer Hospital/Orissa Island and intending to go towards KBR Park will be stopped at KBR Park junction until rally passes KBR Park junction
10.	Traffic coming from Film Nagar/Journalist Colony will be stopped for a while until rally passes Road No. 45 Junction

**TRAFFIC CONGESTION EXPECTED JUNCTIONS:-** 1. VV Statue, 2. KCP Junction, 3. Panjagutta Junction, 4. NFCL Junction, 5. SNT Junction, 6. Sagar Society Junction, 7. KBR Park Junction, 8. Jubilee Check post, 9. Road No. 45 Junction.

Citizens are requested to avoid the junctions and route of Electric Vehicle Rall-E and take alternative routes between 1400 hours to 1730 hours on 05.02.2023. All the Citizens are requested to take alternate route to their destinations and to avoid the above routes during the specified timings and cooperate with the Traffic Police during the period of traffic diversion as above.

**PRESS NOTE**

Hyderabad Traffic Police is continuing its drive against the drunken drivers to ensure road safety. **(4236)** drivers were found under the influence of alcohol during the month of **January-2023**. **3680** Charge sheets were filed against them and were produced in the Hon'ble **3<sup>rd</sup>** and **4<sup>th</sup>** Metropolitan Magistrate Courts, Nampally, Hyderabad. In this regard **3<sup>rd</sup>** and **4<sup>th</sup>** Metropolitan Magistrate Courts awarded imprisonment to the **(365)** respondents. The Hon'ble Courts imposed fine amount of Rs. **94,16,560/-** on remaining **3315** respondents. All the violators sentenced for imprisonment were sent to Chanchalguda Jail. Remaining **556** violators will also be produced in court after filing charge sheet against them.
