Cr No 83/2023 U/s 302 IPC of PS Bahadurpura, S/z, Hyd city

Brief facts of the case:

On 11th Mar 2023 at 1400 hrs Sri Nenavath Gopal, r/o. H No 8-5-14, Opp Mehfil Hotel, Udamgadda, R R Dist complained that his brother in law Mr Tuljappa (Accused) is suspecting his sister Smt Sony @ Anitha (Deceased woman) character who was maintaining a close relation with Mr Balaram, then his brother in law developed grudge against his sister. In the intervening night of 10/11.03.2023 his brother in law beaten to his sister with stick and poured liquor on her genitals and lit the fire, resulting which his siter Smt Sony @ Anitha sustained severe injuries on her stomach, abdomen and thighs, burnt marks injuries on her genitals and died.

Accused Person:

Tuljappa, S/o. Late Mallappa, Age: 61 yrs, Occ: Labor in Dhamanasree Wines shop, r/o H No 8-5-11/123, Udamgadda, Mailardevpally, Rajendra Nagar, R R Dist native of Rajelli, Sedam of Gulbarga, Karnataka State.

Seized Property:

One stick, Match Box & Cigarette Box

Motive:

The accused is frequently quarreled with his wife Smt Sony @ Anitha (Deceased) for she closely move with one Mr Balaram, so the accused informed to his wife that don't talk to with Balram and should not drink with him, but there is no changes of her attitude. On 10th Mar 2023 at night hrs after consumed alcohol the accused along with his wife came to make shift hut at near Puranapool Dargha, Bahadurpura and slept, mean time the Balram also came to their hut and slept, on next day morning i.e. 11th Mar 2023 at about 0100 hrs the accused woke up and went to Mr Kalu belt shop at Parthiwada, Puranapool and purchased Cheep liquor Quarter bottle and drank some liquor and keep the rest with him and came to his hut and found that Balram slept with his wife, After noticed him the Balram is left from his hut at that time accused wife is not having any clothes on her body, then accused got angry with his wife and took one stick nearby his hut and beaten to her indiscriminately and poured liquor on her genitals and lit the fire, resulting which she had sustained severe injuries on her stomach, abdomen and thighs, burnt marks injuries on her genitals and died.

The accused was arrested on 13th Mar 2023 and seized the above property from the possession of accused which was used in the commission of offence. The arrested accused is being produced Sbefore the Hon'ble Court for judicial remand.
