BUSTED CRICKET BETTING ROCKET – HELD (02) PERSONS

The Commissioners Task Force, North Zone Team on credible information apprehended (02) persons at Plot no 48, Rail Enclave, Sikh Village Road Bowenpally, Secunderabad while they were indulging in online cricket betting activity for the ongoing World Cup Cricket Final One day match under limits of Kharkana Police Station.

Name of the accused Apprehended:-

1) Mahesh Ramesh Maniyal S/o Ramesh Maniyal, age : 53yrs, Occ : Clothes business, R/o : Flat no 202, Sai uma apartment, Bowenpally, Secunderabad.

2) Tejash Thakkar S/o Jayanthi lal Thakkar, Age:45 yrs, Occ: Business R/o H.no plot no.48 Rail Enclave, Sikh Village Road Bowenpally. Secunderabad.

Seized :-

1) Net Cash of Rs.40,000/-, Bank balance Rs.3,42,318/- and 6,89,075 points (worth of R.6,89,075/-) total Worth of Rs. 10.71 Lakhs

2) 3 cell phones.

The accused Mahesh Ramesh Maniyal, and Tejash Thakkar involved in cricket betting activities for the ongoing One Day World cup tournament by obtaining betting IDs, Passwords from Rocky r/o.Delhi. They in turn supplying the same to local punters for which they getting 30% commission on profit. Also they have taken master ID from the same bookie and giving IDs to punters and encouraging Cricket Betting activity in the vicinity of Secunderabad area.

The above accused were apprehended while they were indulging in cricket betting activity for the Cricket World Cup Final match between India Vs Australia, and seized Cash of Rs.40,000/- & 3 cell phones. Further on thorough verification it is noticed that they are playing through Chekbet.Co website and have purchased cricket betting points 6,89,075 worth of Rs.6,89,075/- in their betting individual accounts and also freezed Rs.3,42,318/- in their bank account. Entire amount involved both online and offline is of worth Rs.10.71 Lakhs.

The apprehended accused along with seized material handover to SHO Kharkana Police Station for taking further action.

BUSTED CRICKET BETTING RACKET – HELD TWO PERSONS, SEIZED NET CASH OF Rs. 79,000/- AND 02-CELL PHONES.

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with IS Sadan Police apprehended two online Cricket Betting organizers namely Yeshwanth and K. Praveen Kumar. Seized: Net cash of Rs. 79,000/- and 02 Cell Phones at the instance of accused persons.

Yashwanth, age 34 yrs, Occ: Pvt Job, R/o Champapet, Hyderabad

K. Praveen Kumar, age.38 yrs, Occ: Business, R/o Champapet, Hyderabad

Seized Property:-

1) Net Cash of Rs. 79,000/-

2) 02-Cell Phones.

Brief facts of the case:-

The above said accused persons are residing in Champapet, Hyderabad. They are organizing online cricket betting with the help of main bookie Prasad, R/o Miyapur by using online Web Apps i.e. MP KING , Go Exchange etc., duly providing login IDs and Passwords to the punters which is a game of chance to earn easy money illegally under the limits of IS Sadan.

On the tip off information, the Commissioner's Task Force, South Zone Team, Hyderabad along with IS Sadan Police apprehended the above said accused persons at Champapet and seized the amount and cell phones. The apprehended accused and seized material handed over to SHO IS Sadan PS for

further investigation.
