COMMISSIONER'S TASK FORCE, SOUTH EAST ZONE TEAM AND BOWENPALLY POLICE APPREHEND THREE PERSONS TRANSPORTING GANJA

On 08-01-2024, the sleuths of Commissioners Task Force along with Bowenpally Police, Hyderabad, on credible information nabbed 3 notorious Ganja peddlers/transporters 1) Jai Singh Bhati , 2) Rup Chand Kachawa , 3) Prem Kumar Parmar at Diamond Point, Bowenpally who were transporting 130 kgs Ganja from Rajamundry to Medchal in two vehicles i.e. One Bolero, One Maruthi Suzuki swift Red color and seized 130 Kgs Ganja and 3 Cell phones from their procession.

DETAILS OF THE ACCUSED :

1) Jai Singh Bhati S/o Sughan Chand Bhati, 44 years, Business – Tirumala Noodles Compaly at Jeedimetla Industrial area R/o H# 415, Subash Nagar, Jeedimetla, Hyderabad N/o Rajasthan state.

2) Rup Chand Kachawa @ RK Baba S/o Ram Kumar Ji, 27 years, Business – Balaji Ram Kumar Kirana Shop at Jeedimetla R/o H# 65/P, HMT Society near Andhra Bank Lane, Shapur Nagar, Jeedimetla Hyderabad N/o Nagore district, Rajasthan state.

3) Prem Kumar Parmar S/o Kaluram, 35 years, Business R/o Near Saibaba Temple, Subash Nagar, Jeedimetla, Hyderabad N/o Degana Town, Nagour district, Rajasthan state.

SEIZED PROPERTY:

- 1) (130) KGs Ganja
- 2) One Bolero B.no: TS07-UD 0379
- 3) Maruthi Swift car without number plate.
- 4) 3-Cell phones.

(Total worth of Ganja about Rs. 32,50,000/-)

BRIEF FACTS OF THE CASE:

On 08-01-2024, at about 0930 hours on credible information Commissioner's Task Force, South-East Zone Team along with Bowenpally Police intercepted two vehicles i.e. One Bolero B.no: TS07-UD 0379, One Maruthi Suzuki swift Red color without Number Plate at Diamond Point under the limits of Bowenpally Police Station and apprehended (03) persons transporting Ganja at 1210 hrs. A-1 Jai Singh Bhati, A2 Rup Chand Kachawa @ RK Baba and A3 Prem Kumar Parmar.

On enquiry, it is found that the A-1 Jai Singh Bhati has been running Tirumala Noodles at Jeedimetla, Subhash Nagar for (16) years and also running a Donkey Farm in Kucharam of Medak limits for one year. A-3 Prem Kumar Parmar is his working partner in the donkey farm. He along with his working partner Prem

Kumar Parmar and A-2 Rup Chand are close friends. Since their businesses are not doing well they were planning for easy money. While they were enquiring for a better business, about (4) months back they came in contact with Mangilal and Dharmendra who told them that they were procuring Ganja from the supplier Ranjan of Rajamandry and also advised them to procure Ganja and sell it in Hyderabad as there is huge demand for Ganja in Hyderabad. They offered help in procuring the Ganja from their known supplier Ranjan of Rajamandry. On that A-1 Jai Singh Bhati along with A-2 Rup Chand and A-3 Prem Kumar Parmar have planned to purchase the Ganja from that person. They had pooled up to 2.00 lakhs each total of 6.00 lakhs. In order to transport Ganja from Rajamandry, A-1 Jai Singh Bhati arranged his two cars 1) Mahindra Bolero Pick Up truck TS-07/UD-0379 and 2) Unregistered Maruti Swift car. They three went to Rajahmundry on 06/01/2024 while Mangilal and Dharmendra followed in another car. After reaching Rajamandry, Mangilal and Dharmendra took of 6.00 lakhs from them. They contacted Ganja Supplier Ranjan at Rajamandry and purchased (67) packets each containing approximately 2 kg Ganja total weighing approximately 130 kilograms, by paying 5.20 lakhs to Ranjan and Mangilal and Dharmendra shared 40,000/- each towards their commission. After that Mangilal and Dharmendra went away in their separate car. He loaded (27) ganja packets into the dicky Maruti Swift Car while A-2 Rup Chand and A-3 Prem Kumar Parmar loaded (40) packets of Ganja into the back side of Bolero car. Then A-1 Jai Singh Bhati along with A-2 Rup Chand and A-3 Prem Kumar Parmar started to Hyderabad intending to sell the Ganja to needy customers at double the price i.e., 1,500/- per 100 grams approximately. On 08-01-2024 at 1210 hours when the A-1 to A-3 were reached at Diamond Point, Bowenpally in Mahindra Bolero Pick Up truck TS-07/UD-0379 and Unregistered Maruti Swift car along with the Ganja, they were caught red handed by Commissioner's Task Force, South-East Zone Team and Bowenpally Police

The main suppliers of Ganja Ranjan and other accused Mangilal and Dharmendra yet to be apprehended **(Absconding)**
