The Commissioner's Task Force, East Zone Team, Hyderabad along with Falaknuma Police have apprehended (01) Interstate Drug Peddler and (01) Consumer who was in possession of MDMA Drug (Amphetamine) and seized 26 grams of MDMA Drug worth of **Rs. 3,12,000/- approx.**

## FACTS OF THE CASE

On 12-01-2024 at about 1035 hours on credible information the Commissioner's Task Force, East Zone Team along with Falaknuma Police apprehended (01) drug peddler namely Mohd. Amer and (01) Consumer Zubair Ali near opposite Exide Petrol Pump, Vattepally, Hyderabad under the limits of Falaknuma PS and seized 26 grams of MDMA (Amphetamine) from their possession

## **Modous Operendi:**

- Mohd. Amer has passion to act in movies and modelling, one year back, he went to Mumbai in search of any character works and joined to act in some film as artist and stayed in Mumbai.
- Meanwhile he got addicted to consume drugs, later on he returned to Hyderabad started working as Real Estate Mediator and earning which he was getting was not meeting his lavish expenditures as such he decided earn easy money illegally by selling the MDMA Drug in Hyderabad to needy.
- As such he went to Mumbai by flight and purchased the 26 Grams of MDMA Drug from one Arshad, C/o Mumbai and returned to Hyderabad
- On 12-01-2024 in morning hours Mohd. Amer came opposite to Exide Petrol pump, Near Nice Hotel, Vattepally, to deliver the MDMA Drug to his friend Zubair R/o Hashamabad meanwhile on credible Information Taskforce team along with Falanuma Police has caught hold them with contraband MDMA Drug.

## In this case Kingpin/Main Supplier Mr. Rehan Patel @ Arshad C/o Mumbai found absconding efforts are continued to nab him.

The above said person were apprehended Sri S. Raghavendra, Inspector of Police, PS Falaknuma, Sri. G. Naresh, Inspector of Police, East Zone Task Force, and team of East Zone Task Force, Hyderabad City along with Falaknuma Police.

COMMISSIONER'S TASK FORCE, SOUTH EAST ZONE TEAM AND CHATRINAKA POLICE APPREHENDED ONE FAKE ASTROLAGER WHO IS CHEATING INNOCENT PEOPLE ON THE NAME OF ASTROLOGY (BLACK MAGIC) AND EXTRACTING MONEY

On 12-01-2024, the sleuths of Commissioner's Task Force, South-East Zone team along with the Chatrinaka Police apprehended one habitual fake astrologer by name Sirigiri Manjunatha @ Brammam @ Koya Raju @ Arjun Raju @ Manju who is cheating innocent public and extracting huge money on the name of Astrology/Black Magic and seized Net cash of Rs. 14,65,000/- and other material objects.

#### **DETAILS OF THE ACCUSED:-**

- 2) One Mobile Phone
- 3) Credit cards-(01) and debit cards (02) of various Banks
- 4) Other material which was used to perform Black Magic.

## **BRIEF FACTS OF THE CASE:**

On 10-01-2024 received a complaint from Sri Kandhadi Srikanth Reddy in which he stated that his mother is facing cronical health issues since 6 months. In the month of November 2023 he along with his father while watching Local channel they observed one add with Manjunath Phone No. 9866689153 (DURGA DEVI JYOTHISHYALAYAM). Then they contacted him, went to Warangal and met with him, where Manjunath informed them that he will come to their house. Accordingly on 04-11-2023 Manjuanth came to their home and said that they have Naradosham in their house and got believe them that he will cure his mother health by offering the pooja and took Rs. 2,00,000/- cash on the same day. Since then the complainant has paid an amount of rupees Rs.17,00,000/- to him and realized . Hence he lodged complaint and got registered the case in Cr.No:- 17/2024 U/s 406,420 IPC and Sec 2(C) and 7 of Drugs and Magic Remedies Act 1954.

On the receipt of complaint on 12-01-2024, the Commissioner's Task Force, South-East Zone team along with Chatrinaka Police apprehended the said habitual fake astrologer Sirigiri Manjunatha @ Brammam @ Koya Raju @ Arjun Raju @ Manju native of Warangal at MGBS.

On enquiry and found that, the accused Sirigiri Manjunatha is a native of Warangal and facing financial problems. As such he hatched a plan to cheat the innocents on the guise of spiritual basis and to gain money illegally. He published his advertisements as DURGA DEVI JYOTHISHYALAYAM and SAMMAKKA SARALAMMA JYOTHISHYALAYAM in local channels and provided his contact number. On seeing this, the innocent people facing problems contacted him and requested to clear problems. The accused taking this advantage, told them that they have Naradosham, Pranagandam etc..... and terrified, collected photos of victims and huge money on the guise of to perform special Puja/Black magic. As per his plan he cheated the complainant along with some others and gained money illegally.

NOTE ON CONVICTION IN CRIME NO.344/2020 U/S 419, 506 IPC of Chatrinaka Police Station

On 11-01-2024, Smt. Radhika Jaiswal, Hon'ble Chief Metropolitan Magisstrate, Hyderabad has pronounced the Judgment in CC NO. 4842/2021 in Crime No. 344/2020 U/S 419, 506 IPC, wherein the accused person Guggila Rama Krishna Goud S/o Late Venkataiah Goud, was found guilty & sentenced to One month Simple Imprisonment accordingly.

## **GIST OF THE CASE:**

On 20.12.2020 at 18.05 hrs received an English written Complaint from Sri S. Nagendra Kumar Naidu S/o A. Seetharam Naidu, Age: 50 yrs, Occ: Business, R/o: H.No. 18-3-509, 2nd Floor, Hamabowli, Laxmi Nagar, Chatrinaka, Hyderabad In which he stated that he has been living in the above address since 30 years. Around 3 years back One person by Name Rama Krishna Goud purchased one flat in their apartment and created nuisance for all petty issues and he abused in filthy language, several times he along with his friend drank alcohol in the parking area and created inconvenience to all apartment families, recently around 5 days back for no reason he

came to his house i.e. 2nd floor and started abusing his family members in most filthy language and started threatening them with dire consequences. After he again came to his house and warned him saying that his friend is working in police department. On 18.12.2020 at about 10.00 hrs he came to his house with wearing police uniform & without name plate and threatened him and his family members in the name of police. Hence requested to take necessary action against the Rama Krishna Goud, Occ: Cab Driver who wore the police uniform and threatened them in the name of police.

## **INVESTIGATION & PROSECUTION:**

On 20.12.2020 at 18.05 hrs, the complainant Sri S. Nagendra Kumar Naidu S/o A. Seetharam Naidu reported the matter at PS Chatrinaka. Soon after receiving the complaint, registered a case in Crime No. 344/2020 U/s 419, 506 IPC and investigation was taken up by the then SI of PS Chatrinaka Sri M. Mojiram, Sub-Inspector of Police. During the course of investigation, the accused person Guggila Rama Krishna Goud S/o Late Venkataiah Goud, Age: 42 yrs, Occ: Driver, R/o H.No. 18-3-719/34, Rajanna Bowli, JP Nagar, Hyderabad were issued 41(A)(1) Cr.P.C. on 21-12-2020. In this case 07 witnesses were cited and laid the charge sheet within stipulated time.

Smt. Radhika Jaiswal, Hon'ble Chief Metropolitan Magisstrate, Hyderabad conducted the trial into the matter. During the Trial all the witnesses i.e., 07 members were examined in the Court and all of them has deposed their evidence and answered in cross examination done by defense. Basing on the merits of documentary evidence as well as statements deposed by the witnesses, Smt. Radhika Jaiswal, Hon'ble Chief Metropolitan Magisstrate, Hyderabad has pronounced the judgment on 11-01-2024, declaring that the accused person is found guilty and he was Convicted with One month SI.
