In order to provide safe environment to the women of Hyderabad city, at public places as well as during transit, SHE Teams operate in mufti and regularly move around the crowded and scheduled areas where there is a possibility of harassment or teasing of women. Wherever such harassment or teasing is noticed, the respondents are nabbed with video evidence and relevant cases are registered against the culprits.

She teams who were deployed to caught red handed cases during the month of JANUARY, 2024 our SHE Teams caught **(39)** Red handed cases in mufti, widely across various areas in Hyderabad City i.e., **Numaish Exhibition Nampally, Charminar, Afzalgunj bustop, Parade Grounds @ Kite Festival, People's Plaza.** etc., who were indulging in obscene acts, groping, following women inappropriately with video evidence.

Out of cases, **10** cases are got convicted for (3) days imprisonment and 250/- fine and **3** cases are warned & let off and remaining 26 cases pending for appearance of accused before Honourable Magistrate.

APPREHENSION OF ACCUSED PERSON IN CHEATING AND RAPE CASE NEAR INDIAN BAKERY, KISHAN BAGH, HYDERABAD.

The Bahadurpura Police on 19.01.2024 on credible information apprehended the accused who had cheated the victim woman on the false promise of marriage and committed rape.

Details of Accused person.

1) Md Gousoddin @ Mohd Ghouse Patel S/o. Md Shabbir Ahmed, age: 25 years, Occ: Un-employee, R/o. H. No. 1-66, Chenigepally (V), Nyalkal Mandal, Sangareddy District.

Gist of the case:

On 15.01.2024 received a complaint from victim woman stating that the accused person had forcibly committed rape and cheated her by making false promise of marriage. Basing on the content of complaint registered a case in Cr. No. 11/2024 U/sec 417, 420, 376(2) IPC.

MOTIVE:

Accused is native of Chenigepally (V), Nyalkal Mandal, Sangareddy District and in the year 2016 accused shifted to Hyderabad and staying at Kishan Bagh in his cousin brother house. Accused took the phone number of Victim from his cousin and in order to fulfill his sexual desire. The accused during the relationship took the photo of Victim woman and by threatening victim woman forcibly committed Rape and after that by making the false promise of marriage cheated the victim woman.

The case is being investigated by D. Anil Kumar, Inspector of Police, PS Bahadurpura under the close supervision of **Sri. A. Sudhakar, Assistant Commissioner of Police, Falaknuma Division.**
