Charminar Police nabbed Automobile theft offenders

Today i.e. on 01-02-2024 effected the arrest of one accused person along with two receivers and three BJCLs also taken into custody by Charminar Police for their involvement in (04) Automobile theft cases pertaining to Charminar PS and (01) case of Saifabad PS. The arrested accused have been through interrogated the automobile theft offenders/BJLs, they voluntarily confessed to have committed the above said offences. On the virtue of their confession recovered Five two wheelers vehicles worth of Rs.2,20,000/-. The arrested accused persons have been adopted the following modus operandi while committing these offences.

Modus Operandi:

The accused A1 and three CCLs are the residents of Golconda locality, they used to open the locked two wheeler vehicles with master key and taken away. The motive behind the crime is the accused persons desire to live luxury life, due to insufficient income they hatched out the plan of committing theft of vehicles. In order to eliminate their plan the used to commit the theft of vehicles in the dark time of the night at isolated areas like Parking places at Unani Hospital of Charminar, lane opposite to Agra Sweets shop in the limits of Charminar Police Station and also in the limits of Saifabad PS.
