## **SPECIAL ZONAL CRIME TEAM, CCS, DD, HYDERABAD – ARRESTED THE ETERNAL BRIDEGROOM (NITYAPELLIKODUKU)**

Today i.e. on 13.03.2024 the Special Zonal Crime Team, CCS, DD, Hyderabad staff arrested the Eternal Bridegroom (NITYAPELLIKODUKU) by name **A-2** Yeligeti Ranjith @ Yadla Sri Radha Krishna @ Rakesh S/o: Late Yeligeti Ravinder, and **A-1** Yeligeti Sandhya, W/o Yeligeti Ranjith @ Yadla Sri Radha Krishna, Both are residing at Rented House i.e. Plot No 93-B, Road No 4, Vinayak Nagar, Peerzadiguda, Hyderabad, N/o: Near Sri Sai Function Hall, Venkampet (V), Sirisilla (Dist).

**(Arrested on 13.03.2024 at 1200 hrs and being produced before the Hon'ble XII ACMM Court with a prayer to remand for judicial custody)**



### **Details of the property recovered:**

- One four wheeler vehicle i.e. Santro Car B. No. AP 29 E 5504
- One two wheeler vehicle i.e. Activa B.No. TS 08 GH 0092

### **Modus Operandi: -**

The accused persons A1 and A2 collected huge amounts from many innocent girls on the guise of marriage. In the year 2022, while he operating his mobile phone, he noticed that a lot of girls had uploaded their profiles on Telugu Matrimony websites like **Shaadi.com** in an attempt to get marriage offers. Immediately, he hatched a plan to trap the girls who uploaded the profiles in this website by approaching them in the guise of marriage and decided to cheat them by making them emotional blackmail and also decided to collect huge amount from them in the form of Katnam, Marriage gifts and etc.

**Advice to the Public from Hyderabad City Police:** When the people who are going to get married by using the social media plot forms like Shadi.com, Telugu matrimony etc., you should carefully verify the profiles of the other persons and make enquiries personally. Without any verification do not make money transactions.

## Press Note

### Arrest of Mr D. Praneet Rao in the case involving the offences of Criminal Breach of trust by a public servant; causing disappearance of evidence; criminal conspiracy, etc., of Panjagutta PS

- Based on the complaint by Mr D Ramesh, Addl. SP, SIB, on 10.03.2024, a case was registered in Cr No 243/2024 u/s 409, 427, 201, 120 b, r/w 34 IPC, 3 PDPP Act, 65,66,70 IT Act-2000 against Sri D Praneet Kumar @ Praneeth Rao and others for:
  - Developing profiles of unknown persons and monitoring the same clandestinely, un-authorisedly and illegally
  - Causing disappearance of records, both physical and electronic, from the SIB office
  - Copying intelligence information into his personal drives illegally in collusion with unknown persons misusing and abusing his official position
  - Causing destruction of certain computer systems and other official data of the SIB along with the clandestinely obtained data by him un-authorisedly and illegally by turning off the CCTV cameras in collusion with others with an intention to make wrongful gain for himself and others
- The investigation was taken up by Sri P. Venkatagiri, ACP Jubilee Hills and team
- As the investigation done so far revealed that there was prima facie evidence against the accused person, Mr D. Praneeth Kumar @ Praneeth Rao, he was apprehended on 12.03.2024 at around 10.30 pm at his house in Sircilla.
- During the further course of investigation, the accused person has confessed to have committed the offences reported in the case in collusion with some other persons. He was arrested on 13.03.2024 at around 3 am and was produced before the Court seeking judicial custody. The Honourable Court has accepted the same and remanded the said accused person to judicial custody for a period of 14 days. The accused person is being lodged in Chanchalguda Prison.
- Further investigation is under progress.
