The sleuths of Commissioner's Task Force, South West Teams along with staff of Gudimalkapur Police on credible information apprehended two interstate Drug Peddler found in the possession of narcotic substance i..e, Ganja and who were trying to Sell to needy customers near Pillar No: 54, PVNR Express highway, Rethibowli, Gudimalkapur road, Hyderabad and found 34 Kg of Ganja contraband from their possession.

### **Brief about Case:**

The a accused Jivan is a native of Ghodaj (v), Khandar (T), Nanded Maharashtra state. The accused Jivan heard about the Ganja Business through Elder brother by name Ravi,who previously involved in Ganja case in Maharashtra State. Later on Jivan and his brother Ravi hatched a plan to procure the Ganja from Gadchiroli Village, Chanderpur Dist, Maharashtra state is well known for procuring Ganja and earn money. Subsequently, Ravi came to know that, Dhoolpet, Hyderabad is famous for Ganja, if organized the Ganja business in Hyderabad then they can make more profit. As per their plan, Yesterday, i.e., on 13-03-2024, Jivan & Ravi went to Gadchiroli Village, Chanderpur Dist, Maharashtra state and purchased the 34 Kg of Ganja (Rs.6000/- per kg) for Rs. 2,04,000/- from Khanaya. Subsequently, Jivan & Anand (Car driver) came to Hyderabad in Innova Car Br.No. MH02AL4140 (Anand's Car) from his native place to Hyderabad city. On following tip off , South West Zone Team along with Gudimalkapur police apprehended two accused person 1) Jivan & 2) Anand Bheem Singh Jadhav (Car driver) near Pillar No:54,PVNR Express highway, Rethibowli, Gudimalkapur and found 34 Kg of Ganja from his possession.

In this regard a case has been registered against accused persons vide Cr.No. 114/2024 U/s 8 (c) r/w 20 (b)(ii)(C) NDPS Act 1985 of PS Gudimalkapur.
