# NABBED (01) PSEUDO POLICE WHO CHEATING THE PUBLIC ON THE GUISE OF PROVIDING JOBS IN POLICE DEPARTMENT AND SEIZED SUB INSPECTOR POLICE UNIFORM, MOBILE PHONE AND TWO WHEELER

Today i.e., on 13-04-2024, on credible information the Commissioners Taskforce, East Zone Team along with Masab Tank police, nabbed (01) pseudo police who cheating the public on the guise of providing jobs in police department and seized sub inspector police uniform, mobile phone and two wheeler from his possession.

#### Facts of the Case:-

The accused was studied up to Intermediate from Govt. Junior College, Ghanpur, Hyderabad, earlier he was selected as Soldier GD in Army and went to Training at Artillery Centre, but after 6 months of training he was absconded, again in the year 2004 he was appeared for Assam Raifals recruitment and selected as Soldier GD and went to training, during training he suffered with hydrocele disease, and unable to continue training and left from training. He also attended for Police recruitments in undivided AP State but he not succeeded. Then he started eking livelihood by working as Car Driver in Hyderabad. Due to passion over the Uniform force, since 2012 he started wearing the Police Uniform and impersonating as Police officer. Eventually he was attending the various gatherings in Police Uniform and posing as Sub Inspector of Police and Police Constable, as he was exposed as police officer, his villagers and locality people started believed him. Meanwhile to earn easy money he started cheating the Job Seekers and lured and offered them that he will provide the Police Jobs directly.

Accordingly dishonestly he has collected Rs. 2,00,000/- from one victim belongs to Gowri Shanker Banjarahills, Hyderabad and deliberately cheated him, so far he has collected Rs. 11,00,000/- from the various victims.

The above apprehended person along with seized property was handed over to **SHO Masab Tank PS** for taking necessary action.

### ARRESTED ONE ACCUSED PERSON - INVOLVED IN STALKING IN Cr.No 865/2024

On 12-04-2024, in Yousufguda, Cyber Crime Police, Hyderabad City arrested one accused person by name M. Vunnuru Swamy s/o M. Ganganna. Age: 34 yrs, R/o Yousufguda, Hyderabad N/o Ananthapur who was involved in stalking and harassing the innocent people in the guise of catering boys supplier and as per records he is wanted in 11 cases which were registered against him in the Commissionerates of Hyderabad, Cyberabad and Rachakonda.

# **CASE FACTS**:

On 06-04-2024 received a complaint from the complainant R/o Secunderabad, in which he stated that one of his friend had a reception function at a function hall in Bowempally and for which 4 days back he contacted a catering agent by seeing an ad in Justdial for catering boys services and contacted one person by name Venkat and he agreed to arrange 13 persons as Rs.550/-per head and total agreed amount was Rs.7150/-The complainant had shared Groom's Mobile number and another friend's mobile number with the accused for any emergency communication. After completing the reception, the accused demanded Rs.15000 as final amount which they didn't agree. From then onwards the accused made calls to complainant and his family members and abused in vulgar language. The accused also created a fake facebook profile by using complainant's wife name and picture with vulgar content on Facebook. The accused also shared the contact numbers of complainant and his family members on facebook as they run the prostitution business and sharing their contact details with anonymous persons. Due to this complainant and his family members got continuous calls from unknown numbers and facing huge harassment. The accused abused complainant over phone from mobile numbers 9059254585, 9912640810 and 9989641305 continuously. Later the accused had written the personal mobile numbers of complainant and his wife in the public toilets of Madhura Nagara and Ameerpet metro stations and mentioned wife of complainant as call girl. Because of the writings of the accused in the public toilets of Madhura Nagar and Ameerpet metro stations, complainant and his wife were getting continuous harassment calls and messages in a vulgar language. The accused had sent the video recordings of his writings in the public toilets to complainant and putting him and his family in a fear of committing suicide and extorting him to give money due to which complainant and his family members were in traumatic situation. Based on the complaint, Cyber Crime police, Hyderabad registered a case in Cr. No. 865/2024 and investigated in to.

# **MODUS OPERANDI OF ACCUSED:**

Accused used to supply catering boys to the function halls, restaurants and banquet halls for which he posted adds in Justdial and he used to stick pamphlets/posters on walls at various locations in Hyderabad. By watching the adds or posters, whenever a customer wanted catering boys, the accused used to supply them and after the function is over he demands extra payment. When the customer refuses to pay that extra payment for catering boys, the accused will post the contact numbers of customer and his family members in a fake facebook profiles and on public toilets and mention that they are the numbers of call girls. Also, the accused used to abuse the victim over phone and also threaten him to send money. Due to which the victim and his family members get traumatized and harrassment from the accused. The accused used to change SIM cards and Mobile phones for every few days in order to escape from the Police. As per the records, the accused had used over 30 mobile numbers for the commission of the offences.
