PRESS NOTE

Today (20.04.2024) Mr. Kothakota Sreenivasa Reddy IPS, Commissioner of Police, Hyderabad held a coordination meeting with the organizers and other department officials at Basheerbagh, Hyderabad in connection with the upcoming Hanuman Jayanthi on 23.04.2024. Apart from Hyderabad city, officers from neighboring Cyberabad & Rachakonda Commissionerate also participated.

Members of Telangana State Bajrang Dal, Hyderabad Bajrang Dal, Secunderabad Bajrang Dal, Viswa Hindu Parishad and Senior Officers from GHMC, R&B, Fire Services, Electricity, EMRI, TSRTC, HMWS&SB, Transport department and Health & Medical departments have participated in the meeting.

Welcoming the participants Mr. Kothakota Sreenivasa Reddy, IPS requested all to ensure a peaceful festival and rally for which coordination and cooperation of all wings is essential. Some of the points mentioned included regarding the early starting timing of the processions, avoiding use of DJ systems, no bursting of fire crackers, no throwing of vermilion or gulal on the passers-by, no carrying of sticks/swords/fire arms, no provocative slogans, speeches, songs, displaying provocative banners, use of limited number of vehicles and no disturbance to people from other communities. Use of Drone Cameras is not permitted without prior permission of Police Department.

Hyderabad City takes pride in being a truly multi-cultural city and we have to ensure that peace and tranquility continues to be maintained without giving scope to anybody pointing out any bias towards any community.

He further requested all not to indulge in rumours, spreading provocative posts, fake messages, etc on social media.

Since this is election time the organizers should not violate the conditions of Model Code of Conduct (MCC) and give any scope to find fault in the conduct of the event. No Political symbols or Political speeches will be permitted during the Hanuman Jayanthi.

Later CP Hyderabad along with other department officials and the organizers inspected the nearly 12.2 KM route of the main procession.

CP requested all the departments to expedite the pending works.

A Joint Control Room will be setup at ICCC, Banjarahills from 8 AM on 23.04.2024 wherein officials of various departments will be available to attend to any problem.

APPREHENDED 03 ACCUSED PERSONS WHO KIDNAPPED A BOY FOR RS 15 LAKHS RANSOM - RESCUED IN SECUNDERABAD-MARKOOK POLICE, SIDDIPET.

On 19.04.2024 on Credible information the Commissioners Taskforce East Zone Team along with Markook Police of Siddipet Commissionerate co jointly rescued one Boy from the Clutches of kidnappers namely. 1) Chandan Kumar 2) Anup Chowdhari and 3) Meghnath Karmakar - Rescued Boy from their Instances.

Accused details:

- 1) **Chandan Kumar** s/o Balishewar Das, Age: 18 yrs, N/o Jharkand.
- 2) **Anup Chowdhari** S/o Suraj Pari, age: 21 Yrs N/o Bihar.
- 3) **Meghnath Karmakar** s/o Sukrom. Koumakar, Age: 18 yrs, N/o Assam.

Brief facts of the case:

Facts of the case are that on 19-04-2024 one Boy by name Tovid Alam S/o*Tabrez Alam 07 years old R/o Karkapatla, Markook, Siddipet Dist.N/o: Bihar was going to school with his friends while he is on the way to school two unknown Persons Came to him and abducted Boy by Saying "I will buy chocolates and Slippers to you. The parents of the Boy noticed that the boy was not returned to home from school and caused enquiry with his school mates who are accompanying the boy and came to know that the boy was abducted. On the complaint of Tabrej Alam who is a father of Boy a case in Cr.No 46/2024. u/s 363 IPC at Markook PS was registered and investigated into.

While the investigation is under process the complainant received a call from kidnappers and demanded Rs 15 Lakhs as Ransom and threatened the complainant that they would harm the Boy if 15 lakhs were not given to them and also told to keep cash ready and wait for further directions.

Acting on the tip-off the Commissioners Taskforce East Zone Team along with Markook Police nabbed kidnappers at Secunderabad Railway Reservation Complex and rescued Boy Tovid Alam fom their Clutches. On enquiry the accused were identified as Chandan Kumar, Anup Chowdhari and Meghnath who are natives of Jharkand, Bihar and Assam are working in a small scale industry at Karkapatla the earnings are not meeting their lavish expenditures so they hatced a plan to kidnap the Boy and Extort huge money. Accordingly they collectively moved to Karkapatla and Kidnapped 07 yrs old boy and sped away.

The Rescued Boy and apprehended accued persons were handed over to Markook Poilce for taking further action.

The above arrests were made under the supervision of **Sri Ande Srinivasa Rao** Addl.Dy.Commissioner of Police, Commissioner Taskforce along with **A.Nagarjuna**, Inspector of Police, East Zone Taskforce and Sis S/Sri **P.Nagaraju**, **M.Anantha Chary**, **S.Karunakar Reddy** along with East Zone Taskforce Team and Markook Police.

**HELD ONE ACCUSED WHO POSED HIMSELF AS A DOCTOR AND WAS
ALLEGEDLY TREATING PATIENTS**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Kalapathar Police nabbed one accused who posed himself as a "**Hair Transplant Doctor**" and giving treatment to the patients for a Lipoma without any valid doctor course certificates and cheating the innocent victims/patients.

BRIEF FACTS:-

The accused **Aslam Shafi Sayyed** is born and brought up from Hyderabad and residing along with his family in Bahadupura area. He is working as receptionist in Redifine Hair Transplant & Plastic Surgery Centre at Gachibowli, Hyderabad. But, he posed himself as a Hair Transplant & Skin Doctor and he didn't have any authorised medical certificates. Further, for the last couple of months he started Lipoma treatment to the patients without any skill/experience at his residence.

On tip of information, the South Zone Task Force Team, Hyderabad have apprehended the above said accused person and handed over to Kalapathar PS for further action.

In this regard, a case has been registered in Cr.No. **67/2024 U/s 417, 419, 420 IPC of Kalapathar PS**, Hyderabad and being investigated.
