HYDERABAD CITY POLICE

Smt. P. Pushpa Latha, Honourable Special Sessions Judge for POCSO, HACA Bhavan, Nampally, Hyderabad, has pronounced one judgement today. Accused person Mohd. Saleem, Aged 45 years, Occupation: Auto Driver. In SCPCS No : 75/2021 vide Cr no: 135/2020 u/s 363 & 376AB IPC sec 5(m) r/w 6 of protection of children from sexual offences act 2012 of Madannapet police station. Accused convicted for Rigorous imprisonment for 20 years, and to pay a fine of 5000/-. Also granted Rs. 2,00,000/- compensation to victim girl.

The mother of the victim has 2 children, of which the victim girl is aged 6 years. The accused residing in the adjacent lane, lifted the victim girl on his shoulders and abused her on the terrace forcefully. Later threatened the victim not to disclose to anyone. The Victim cried in pain and complained to the mother about the incident. The mother took her to Madannapet PS and case was registered and brought to Bharosa for 161 Cr.PC statement recording. Medical evidence was also collected in Bharosa Center.

Upon the receipt of this complaint, Sri. G. Sateesh , SI of Madannapet Police Station, registered FIR in Cr no: 135/2020 u/s 363 & 376AB IPC sec 5(m) r/w 6 of protection of children from sexual offences act 2012 and investigation was taken up by Sri. SVN Shivaram Sharma, ACP, Santoshnagar Division. After thorough enquiry, filed charge sheet accordingly.

The Bharosa Centre has facilitated the victim & her family in Counseling, Medical support, Legal support, financial support, Submission of documents for Compensations, apart from home visit by Bharosa staff.

During the 164 statement, court briefing, court trials & mock court trials were done by the admin, counselor & support person, so that the victim feels more comfortable while facing the judge. The concerned efforts by the Investigating Officers, Sri. G. Sateesh, SI of Madannapet Police Station, Sri. SVN Shivaram Sharma, ACP, Santoshnagar Division, Sri. Prathap Reddy, Public Prosecutor, Smt. Kalpana, Legal Support Officer – Bharosa, Other Bharosa Team and Court Duty Officer by name Sri. N. Gangaraju, PC 9872 of Saidabad PS & Process Duty Officer Sri. D.Sudhakar, PC 3081 of Madannapet PS contributed immensely **during the course of trial which ended in Conviction, being awarded by Smt. P. Pushpa Latha, Honourable Special Sessions Judge for POCSO, HACA Bhavan, Nampally, Hyderabad.**

The concerted efforts of Police Officers and Officers at Bharosa Centre were closely monitored by Smt. D Kavitha, DCP, Women Safety, Prasanna Lakshmi, ACP, Women Safety, Hyderabad apart from T. Jyothsna, Inspector Bharosa and Mary Augustine, Centre Administrator.

So far 47 cases of MCC violation have been registered.

1. Flying Squad Teams (FST) are in operation for checking MCC violations. Each FST consists of 1 ASI/HC with 3 Armed PCs along with one Special Executive Magistrate and a Videographer. Each Assembly Segment will have 03 FSTs working in three shifts.
2. Static Surveillance Teams (SSTs) are in operation for checking MCC violations. Each SST consists of 1 ASI/HC and 2 unarmed PCs along with Executive Magistrate and Videographer. Each Assembly Segment will have 03 SSTs working in three shifts.
3. Two Additional Nodal Officers in the rank of DCP for 2 Parliamentary Constituencies (DCP South zone for Hyderabad PC and DCP. East zone for Secunderabad PC) and 15 Sub-Nodal Officers in the rank of ACP were already deployed for 15 Assembly Constituencies of Hyderabad City under the direct supervision of Commissioner of Police, Hyderabad (Nodal Officer for Hyderabad and Secunderabad PCs)
4. Since the announcement of Elections total 1020 persons have been bound over in 457 cases, and the process will continue till completion of elections. A special focus has been given on binding over of History sheeters, Rowdy sheeters, Communal offenders and previous election offenders etc. Already during TSLA elections 2023, in 1609 cases, 4137 History sheeters/Rowdies have been bound over.
5. As on today, total 475 NBs have been executed and 155 NBWs are still pending under various categories for which special teams, including special teams for outside States, have been formed for execution of pending NBWs on top priority.
6. Hyderabad City Police is regularly conducting Vehicle checking's flag Marches. CASO, Hotel & Lodges Checking's Railway Stations & Bus Stand Checking for Enforcement work.
