APPREHENDED ROBBERY GANG AND DETECTED THREE CASES

Based on credible information, the sleuths of the Commissioner's Task Force, North Zone Team, Hyderabad City, apprehended a Gang involved in Robbery cases and detected three cases.

Details of Accused person: -

1. Katekala Rohan Raj @ Shiva s/o. K.Govardhan, age: 19 years r/o. Neredmet.
2. V.D.Vivian Raj s/o. V.Dhan Raj, age: 19 years r/o. Trimulgherry, Secunderabad.
3. Yugen Alex s/o.Y.Charlie, age 19 years, r/o.Lalbazar Secunderabad (Receiver)
4. Narpat Singh s/o. Amar Singh, age: 19 years, r/o. Lalbazar, Secunderbaad (Receiver)
5. Sirigiri Raj Kumar s/o. S.Ravi, age: 25 years, r/o. Malkajigiri, Secunderabad (Receiver) and (04) Boy Juveniles.

Detected Cases:-

- 1) Cr.No.166/2024 U/sec.392 IPC of Trimulgherry PS
- 2) Cr.No.125/2024 U/sec.392 IPC of Market PS
- 3) Cr.No.337/2024 U/sec.380 IPC of Neredmet PS

Seized Material:-

1. Three cell phones: Poco C-65, Redmi-10 A, Vivo cell phone.
2. Two motorcycles used for the commission of the offenses.

➤ Facts of the case :

The accused persons, Katekala Rohan Raj @ Shiva, V.D. Vivian Raj, and four boy juveniles, are teenagers and residents in the vicinity of Lalbazar and Trimulgherry. The gang leader is Katekala Rohan Raj @ Shiva. They are addicted to alcohol, smoking cigarettes, and other vices. To finance their lavish lifestyles, they planned to rob or steal cell phones, sell the stolen property, and gain easy money.

On 07-05-2024, the accused Katekala Rohan Raj @ Shiva, V.D. Vivian Raj, and two boy juveniles, riding a Honda Activa (Reg.No.TS 10 ES 8074), robbed a Poco cell phone from a passerby and sold it to receiver Yugen Alex. On 08-05-2024, the same group used the Honda Activa to steal two cell phones from a house, selling one to Narpat Singh (mobile shop owner at Tirumalgiri) and the other to an unknown person. On 11-05-2024, Katekala Rohan Raj @ Shiva and two boy juveniles, on a Bajaj Discover motorcycle (Reg.No. AP 11 AC 3009), robbed a Vivo cell phone from a passerby near Clock Tower, Secunderabad, and sold it to receiver Sirigiri Raj Kumar (mobile shop owner at Neredmet).

Acting on credible information, the North Zone Task Force Team, Hyderabad City, meticulously tracked and apprehended the accused persons, recovering stolen property and motorcycles used in the crimes.

Appeal to the Public:-

- The public is advised to be more cautious while talking on mobile phones on roads during night hours or in lonely places
- Mobile shop owners are advised not to purchase cell phones without bills, particularly from unknown/suspicious persons. If any such persons are encountered, they should be immediately reported to the local police.
