SOUTH ZONE TASK FORCE RAIDED ILLEGAL HOOKAH CENTRE RUNNING IN GUISE OF CAFE AND APPREHENDED (07) PERSONS

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Bahadurpura Police raided on the establishment of "**The wolf cafe & lounge**" coffee shop, in the limits of Bahadurpura Police Station and apprehended the owner and 6 customers. The owner Muzammil has been providing Hookah to the customers illegally to earn easy money.

Details of accused:-

- 2) **Mohd Furkhan Ahmed** S/o Mohd Iftikhar Ahmed, Age.18 yrs, Occ: Hookah Center Maneger, R/o Near Kalapathar PS, Hyderabad (**Manager**)
- 3) **Mohd Nazeer** S/o Mohd Azeemuddin, Age.41 yrs, Occ: Al Madina Pan Shop, R/o Tadban, Hyderabad, (**Hookah Flavors Supplier**)
- 4) **Sayed Zameer** S/o Syed Allahbakash, Ag:25 yrs, Occ: Business, R/o Puranapool, Hyderabad (**Consumer**)
- 5) **Syed Sohail** S/o Syed Khayyum, Age:20 Yrs, Occ: Pvt. Job, R/o Karwan, Hyderabad, (**Consumer**)
- 6) **Syed Fazal** S/o Syed Anwar, Age.20 Yrs, Occ: Student, R/o Puranapool, Hyderabad (**Consumer**)
- 7) **Mohd Mukkram** S/o Mohd Musa, Age: 20 yrs, Occ: Pvt Job, R/o Karwan, Hyderabad (**Consumer**)

Property seized:-

1. Hookah Pots – 19
2. Hookah Flavors – 05 Box (Each Box 50 Grams)
3. Hookah Coils- 06 Boxes
All Worth Rs.30,000/-

Facts of the case:-

The accused Mohd Abdul Muzammil is native of Hyderabad, running a coffee shop in the name of "**The wolf cafe & lounge**" since long time. Due to insufficient profit in business he hatched a plan to serve illegal Hookah. As per his plan he is serving Hookah pots by mixing the Hookah flavors which contains Nicotine & suspicious Hookah flavors as ingredient, by violating the rules laid down under COTP Act and charging higher price for Hookah pots and gaining easy profits. For that, he is purchasing Hookah flavors from one pan shop owner Md. Nazeer. The accused Muzammil previously involved in Cr.No.262/2023 U/s 272, 273 IPC & Sec 20(2) COPTA Act of Bahadurpura PS.

On credible information the Commissioner's Task Force South Zone Team along with Bahadurpura Police apprehended accused persons and seized Hookah

material. The accused and seized material were handed over to **SHO, Bahadurpura PS** for further action. The Bahadurpura Police have registered a case in Cr. No.289/2024, U/s. 223 BNS, Sec 6 & 7 of COTP Act and took the up investigation.

The above arrests were made under the supervision of Sri S. Raghavendra, Inspector, SIs Sri N. Naveen, K. Narsimulu & Staff of Task Force and Bahadurpura Police.

They became habitual for earning easy money by stealing two wheelers. They have committed (04) two wheeler thefts in Langerhouz PS and Narsingi PS.
