Modus Operandi:

The accused Surada Chandini @ S.Kumar is native of SrikakulamDist., of Andhra Pradesh who is originally a male person, but got medically operated and converted as Transgender. She is Organizer. Her sub-Organizers also converted themselves as Transgenders from male.

The above accused Sl.No.1 to 4 who are originally male in gender, but as per the guidance of Surada Chandini @ S.Kumar they wearing woman dresses, impersonating as female (Transgender) at important Junctions, extorting money from Shop keepers, Vehicle owners by stopping vehicles even after green signal, also pedestrians, causing traffic Jam and creating nuisance. They have created Whats-app groups and exchanging their activities areas of operations, facing problems etc.,

Appeal to general Public:-

- Not to entertain this type of people by giving money.
- If anyone causing trouble at Junctions, or any functions immediately dial 100 or call local Police.
- Help Police in curbing such illegal activities.

The apprehension was carried out by Sri K.Saidulu, Inspector of Police, Srinivasulu Dasu, P. Gnanadeep of the North Zone Task Force and team along with Kharkana police.

SEIZED PROPERTY:

- 1) Black Magic Material (Photos, threads etc)
- 2) Net Cash of Rs. 8000/-
- 3) One Vivo Mobile Phone

MODUS OPERANDI:

Investigation reveals that, the above accused person is a native of Narayanpet, Mahaboob Nagar. In the year 2012 he came to Hyderabad for livelihood and resided various localities in city. Since then he is cheating public in the name of Black Magic. Since 2 months he took one rental house at Near Chilla, Jahangirabad, Bandlaguda, Hyderabad and cheating innocent people by saying he will do black magic with their photos and cure the deceases and family & financial problems and collecting huge amounts.
