# CAUGHT IN THE ACT, HAVE NO PLACE TO HIDE, MISBEHAVED IN HYDERABAD GANESH UTSAVS, NOW 200 BEHIND BARS.

Hyderabad, September 2024 – During the recent 11- days Ganesh Chaturthi celebrations, SHE Teams actively worked to safeguard women at crowded areas like Khairatabad Bada Ganesh and other crowded areas. Out of the 996 individuals caught Red-handed for misbehaving with women, 200 persons were produced before the Hon'ble Court, found guilty and awarded with 3 days imprisonment along with a fine of Rs 1,050/- U/s 292 BNS & 70 © Hyderabad City Police Act. These offenders were apprehended with video/photo evidence of their indecent behaviour in various public places in Hyderabad.

The remaining offenders, for whom video evidence could not be captured, were strictly counseled in the presence of their family members. They were warned about their conduct and ordered to attend SHE Teams for counselling sessions at regular intervals. These individuals will remain under surveillance by SHE Teams to monitor their behaviour and ensure they refrain from repeating such actions.

The aim of SHE Teams is not only to punish offenders but also to correct the misguided youth, by influencing their mindset and attitude towards women in the society through counselling, attendance etc. All will be counseled in the presence of Psychologists in a separate counselling session. This initiative emphasizes psychological reform and offers individuals a chance to change their behaviour and perception towards women.

# NABBED CHEATERS - RECOVERED 29.92 LAKH RUPEES WITHIN (24) HOURS OF OFFENCE

The accused Rohan Kadam is native of Maharashtra State and he has been working in Jyothirling Refining at Pot market Secunderabad since (04) days only. On 03-10-2024 Owner of the Jyothirling Refining gave 400 grams gold to him for handing over to S.M.Jewellery, Secunderabad and bring cash. The accused with pre-plan handed over gold to S.M.Jewellery, and taken cash of Rs.30 Lakh, but didn't handover the money to his owner and along with his native persons Muzammil Baligar and Pruthviraj Salunkhe & Prasad (absconding) took the cash away and left Hyderabad City in Maruthi Swift Car Reg.No. MH 11 DN 5500 for Bangalore. The Commissioner's Task Force, made good efforts and apprehended Prime accused Rohan Kadam and his one of accomplice Muzammil Baligar along with Market police. Other accomplice Pruthviraj Salunkhe and 2) Prasanth both were found absconding.

The Commissioner's Task Force North Zone along with Market PS police made good efforts and within (24) hours of offence, apprehended

accused and seized stolen cash Rs.29,92,000/-, Maruthi Car used for commission of this offence and 2 Cell phones.

The apprehension was carried out by S/sri K.Saidulu, Inspector of Police, SIs P. Gnanadeep, Srinivasulu Dasu of the North Zone Task Force along with team and Sri P.Raghavender, Inspector of Police and Srivardhan SI of Police Market PS.

In view of forthcoming Dussera, Diwali festival huge demand of Fire Crackers is there and to exploit that gain the accused had stored huge quantity of Explosive Fire Crackers including bombs, sprinklers and other items, illegally at a residential area without any valid license from

the concerned authorities and knowingly that, storing of fire crackers in residential area

without any precautionary measures which may cause severe damage to the human lives,

property of the residents if any untoward incident occurs.

On 03-10-2024 on reliable tip-off task force raided above godown and seized huge quantity of Fire crackers.

The apprehended accused person along with seized material were handed over to SHO,

Begum Bazar PS for further action.
