DETECTED MURDER FOR GAIN CASE OF DOMALGUDA PS - ONE HELD

Cr.No: 35/2024, U/s 302,394 IPC OF DOMALGUDA PS,

The sleuth's of Commissioner's Task Force, Central Zone team along with PS Domlaguda Police solved the mystery behind the mysterious murder for gain of a old aged woman with the arrest of prime accused Mahesh Kumar Mukhiya N/o. Bihar State which was occurred on 31-01-2024 in the limits of Domalguda PS.

➤ **Details of apprehended accused :**

Mahesh Kumar Mukhiya S/o. Kishan Mukhiya, age. 26 yrs , Occ. Labour, N/o. Sujoul Village, Madhubani(Dist), **Bihar State**

➤ **Details of deceased:-**

Smt. Snehalatha Devi W/o. Mahesh Kumar , age. 62 yrs, Occ. House wife

➤ **Facts of the case :-**

Accused Mahesh Kumar Mukhiya is native of Bihar State. Due to financial problems for doing any labour work with the help of his relatives in the month of Dec'2023 he came to Hyderabad and took shelter at his sister's residence at Hyderabad. Through relative known sources he joined as care taker at the residence of complainant Savarya Pawan Guptha for care take of Complainant mother Snehalatha Devi .aged about 62 yrs who is suffering with age element factors and started working as a housemaid on monthly salary basis with accommodation provided in their house. The inmates goes to their business at morning hours and return at night hours by leaving the aged woman with care taker and the accused observe the movement of inmates.

By taking this advantage the accused hatched a plan to commit theft of gold ornaments , cash other valuables for clear his debts as well as maintains luxurious life and waiting to take opportunity.

For implement his plan, he informed to his associates who are native of Bihar State and advised them to accomplice in his plan to commit theft of Gold, Cash other valuables in the said house and sharing the booty.

Before three days of offence one his accomplice came to Hyderabad and met with the accused, decided to commit a theft and they have arranged one bag which consisting of pieces of clothes, chain, and Cello tape for used in the commission of offence.

On 31-01-2024 morning hours the inmates went to their business and only the aged woman by name Smt.Snehalatha (deceased) present in the house by leaning on Sofa. Immediately the accused Mahesh Kumar Mukhiya with his accomplice closed the mouth by keeping a cloth pieces and hold hands and tied in the chair with a cloth pieces covered cell plaster to the mouth , nose with an intention to kill her to conceal evidence and committed theft of gold ornaments and cash which were available in the Almiarrah , later the accused confirmed that the aged woman found died due to breathing suffocation and escaped from the place with the booty with his belongings.

➤ **ARREST:-**

The Task Force, Central Zone team verified the CCTV footages at all possible places and with the reliable sources identified the accused Mahesh Kumar Mukhiya who is prime accused in this case.

Acting on reliable tip off Task Force Central Zone team apprehended prime accused Mahesh Kumar Mukhiya and detected mysterious murder for gain case of Domalguda PS. In this case other offenders are at large. Efforts are continuing to apprehend the absconding accused.

The apprehended accused person handed over to SHO, Domalguda PS for further investigation.

The brief facts of the case:

On 04-10-2024 found that the accused persons circulated abusive morphed photos of Sri A. Revanth Reddy, Hon'ble Chief Minister of Telangana State through in the WhatsApp group name "KTR పేస రంగాయెడ్డి..." The post which is circulating in social media had potential to create political tensions and also promote disharmony among the public and derogatory comments, insulting Hon'ble Chief Minister of Telangana Sri A. Revanth Reddy, which may leads to the law and order problem in the society

The Cyber Crime Police made sincere efforts to trace the accused persons and produced before the Hon'ble XII AMSJ Court, Nampally, Hyderabad and were remanded.

The investigation was done by K. Madhulatha, Inspector of Police and team of Cyber Crime P.S under the supervision of Sri. Chand Basha, Asst. Commissioner of Police, Cyber Crime P.S. Hyderabad.

SOUTH-EAST ZONE TASK FORCE TEAM RAIDED GODOWNS OF DUPLICATE GOLD FLAKE & BANNED CIGARETTES UNDER THE LIMITS OF MALAKPET, MADANNAPET & SHALIBANDA POLICE STATIONS - APPREHENDED (05) PERSONS- SEIZED HUGE STOCK OF DUPLICATE & BANNED CIGARETTES-WORTH OF RS. 1,00,00,000/- APPROX.

On 05-10-2024, acting on credible information, the sleuths of **Commissioner's Task Force, South-East Zone Team, Hyderabad** along with the concerned local police, simultaneously raided godowns of duplicate Gold Flake & banned foreign cigarettes under the limits of Malakpet, Madannapet & Shalibanda Police Stations. Apprehended (05) persons who are importing, storing and supplying the cigarettes i.e., duplicate Gold Flake Cigarettes, banned cigarettes i.e., Paris, Win, Esse, Don, Peacock which are highly harmful to human health. BRIEF FACTS:

On thorough enquiry, it is revealed that Mohammed Faisal, Raju Yadav, Mohammed Akbar, Mohd Hasan Uddin, Mohammad Afzal, and Mohammed Shakeel are doing illegal duplicate Gold Flake & banned cigarettes business by procuring huge quantities from different suppliers from other states and storing their godowns at Malakpet, Madannapet and Shalibanda localities. On demand they are supplying to needy customers in AP & Telangana states through transport and gaining huge profits. The consumption of the above products is highly harmful to human health.

The above persons along with seized property are handed over to concern police stations for further legal action.

The raids were conducted under the supervision of **Sri K.N. Prasad Varma, Inspector of Police, South-East Task Force**, by Sub-Inspectors **Sri Sk. Kaviuddin, Sri P. Sairam and Sri M. Madhu** along with the **South-East Task Force team** and the staff of the Malakpet, Madannapet and Shalibanda Police stations.

BUSTED ILLEGAL STORAGE, SALE OF FIRE CRACKERS GODOWN – ONE HELD

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Mirchowk Police on credible information busted an illegal storage, selling of Fire Crackers situated at H.No. 23-5-632/1, Alija Kotla, Mirchowk, Hyderabad under the limits of Mirchowk PS and found huge quantity of Fire crackers including bombs, sprinklers and other items illegal storage. Apprehended its proprietor by name Shiva Kumar Goyal. The proprietor was kept carelessly in violation of safety norms for illegal gains. Seized Fire Crackers worth Rs. 1,50,000/-

➤ Facts of the case:-

The accused Shiva Kumar Goyal is residing in the limits of Mirchowk, Hyderabad and running Water Plant Business and also running seasonal business at Mirchowk.

In view of forthcoming Dussera & Diwali festivals huge demand of Fire Crackers the accused had storage huge quantity of Explosive Fire Crackers including bombs, sprinklers and other items without any valid license from the concerned authorities and knowingly stored the fire crackers in residential area without any precautionary measures which may cause severe damage to the human lives, property of the residents if any untoward incident occurs.

On reliable tip-off the Commissioner's Task Force South Zone Team along with Mirchowk Police apprehended the accused person, seized the above said fire crackers. The accused and seized material were handed over to SHO, Mirchowk P.S. for further action. The Mirchowk Police have registered a case in Cr. No. 217/2024, U/s 287,288 BNS, Sec 9 (B) (1) (b) of Explosive Act-1884 and took the up investigation.

The above arrest was made by Sri. S. Raghavendra, Inspector, South Zone Task Force, SIs Sri G. Anjaneyulu, K. Narsimulu, N. Naveen & staff of South Zone Task Force, Hyderabad along with Mirchowk Police.
