SOUTH-EAST TASK FORCE– NABBED (01) NOTORIOUS ROWDY SHEETER & LAND GRABBER, WHO IS ABSCONDING SINCE LONG TIME & EXECUTED (11) NON BAILABLE WARRANTS.

On 04-03-2025, the sleuths of Commissioner's Task Force, South-East Zone team, Hyderabad apprehended (01) Notorious Rowdy Sheeter/Land grabbar of Bandlaguda Police Station who is absconding since long time and executed (11) Non Bailable warrants.

DETAILS OF THE ROWDY SHEETER:

Ali Bin Mahmood Jabri @ Ali Jabri S/o Mahmood Bin Ahmed Jabri, Age: 32 yrs, Occ: Business, R/o Ismail Nagar, Bandlaguda, Chandrayangutta, Hyderabad (Rowdy Sheeter of Bandlaguda PS)

BRIEF FACTS:

On 04-03-2025, the sleuths of Commissioner's Task Force, South-East Zone team apprehended (01) Notorious Rowdy Sheeter/Land Grabber of Bandlaguda Police Station by name Ali Bin Mahmood Jabri @ Ali Jabri who is involved in (21) cases including land grabbing, cheating, forgery, threatening and attempt murder cases in Hyderabad & Rachakonda Commissionerates. On interrogation, it came to know that, the said rowdy sheeter/Land grabber is absconding since long time and avoiding the court trails in the following cases and the Hon'ble Court's has issued Non-Bailable Warrants against him.
