THE GIST OF THE CASE :

The brief facts of the case are that on 16.03.2025 at 1130 hrs received a complaint from driver of the Hon'ble Member of Parliament Smt. DK Aruna garu, in which he stated that on 15-03-2025 at night hours he slept in driver's room of first floor and Madam's daughter & lady workers slept at second floor, but at about 0350Hrs, complainant heard some noise so immediately he woke up and saw, but no one found. At about 0600hrs on checking CCTV footage, it is noticed that one unknown person wearing mask entered into premises by wall and entered into first floor kitchen room by breaking down window glass and cut off the CCTV wire and dwelled in the house for some time and fled away from the house. Therefore, he requested to take necessary action as per law. H

Basing on the contents, a case in Cr.No 200/2025 U/s 331(4), 305(a) BNS was registered and Sri. R. Madhusudhan, Detective. Inspector of Police, Jubilee hills Police station took-up the investigation.

With our staff of West Zone 8 teams were formed to apprehend the accused and efforts were on war foot.

During the course of search for the accused, by checking CCTV Cameras today 18.03.2025 at around 1000 Hrs apprehended one accused at Aman nagar-B, near his residence & seized above items, producing before the Hon'ble Court and further investigation is continued.

The above good work done by our Police Officers is appreciated.

THE GIST OF THE CASE :

In which he stated that on his four wheeler (MG.HectorDeseil.2.0), B.no:TS09FH1782, Chassisno: MZ7AD1CDE2H000562, Engine. Number: 4039949, when he stopped at Relax Sandhya Wines Shop, opposite Green Park Hotel, Ameerpet. He left his car running and went towards the shop by keeping the car aside an unknown person, got into the car and drove off towards Ameerpet and drove off quickly and left the place. Hence, he requested to take necessary action as per law.

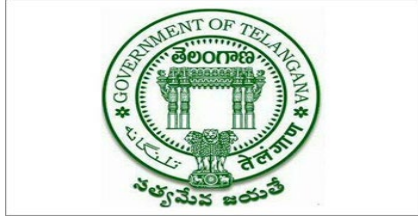
Basing on the above complaint,a case in Cr.No Cr.no **207/2025** U/s 303(2) BNS is registered and being investigated.

Accused sent to judicial remand Chanchalguda Prison and further investigation is continued.

A Sexual Assault on victim minor girl occurred on 29.08.2023 and was reported on 30-08-2023, wherein the accused person by name Amar Nepali has committed rape on a minor girl and threatened the minor girl by showing a knife that not to tell her family members about the incident. Due to fear, she did not disclose to family members about the incident. In this regard the family members of victim girl approached police station and lodged a petition.

In this regard a case has been registered vide Cr. No. 132/2023 U/s 376(2)(f) IPC and sec.3&4 of POCSO Act and the accused by name, Amar Nepali, S/o Dhane, age-37 years, Occ- Unemployed, has been taken into custody and sent him to judicial remand.

The above mentioned Case ended with Conviction Judgment pronounced on 18-03-2025 By Hon'ble XII Additional Sessions Judge, Hyd. In SCPC.No. 279/2023 Vide Cr. No. 132/2023 U/s 376 (2)(f) IPC , & Sec. 3 R/w 4 of POCSO Act 2012 Of Domalguda Police Station. On the file of Honourable XII Additional Metropolitan Sessions Judge , Nampally , Hyd.
