Consuming these stale/spoiled offal's of sheep & Goat can lead to various health issues. Acting on a tip the Commissioner's Task Force, South West Zone team and Veterinary doctor, Goshamahal circle -14, GHMC, Hyderabad raided A to Z Sheep & Goat offal store and Seized Stale/ spoiled offal's of sheep & goat ( Paya, Mudi , Beeja, Gurde, Kaleji ) about 12 tons total worth of property in Rs. 8,00,000/- from his possession.

Facts of the case: On 14th March 2025, received a complaint from Sri, C. Raju R/o Road No. 8, Filmnagar, stating that an unknown person had entered into his house, searched for valuables in 2nd and 3rd floors of his house and committed theft of 2 Dimond rings and 1 headphone from his bed room and fled away along with other accused on a two-wheeler.

On registering the case in Cr. No. 180/2025 U/s 305(A),331(4) BNS, police collected all the technical evidence through CCTV cameras, location of the earbuds and kept sharp eye over the suspects. Today i.e on 19.03.2025, the three accused are found, while they are trying to sell the stolen property near Shaikpet Nala. The three accused are arrested by M. Sathish Kumar-SI, Surender Rathod-PC, Imtiaz Hussain-PC and recovered the stolen property along with a bike, which was used by them in commission of offence.
