## PRESS NOTE MIRCHOWK POLICE NABBED ONE SNATCHING GANG WHO INVOLVED IN CR.No.84/2025 U/s 304(2) r/w 3(5) BNS of Mirchowk PS

## **Brief Facts of the Case:**

On 17-04-2025 the complainant Sri D.Raju S/o D.Narsimha Rao, age: 28 years, Occ: Cashier in BPCL at Kalikabar, Hyderabad, R/o Present residing in the said BPCL, Kalikabar, Hyderabad reported that on 17-04-2025 at around 10.05 AM while he was on duty and serving petrol to the needy customers, meantime two persons came by one two wheeler without number plate and asked him to serve petrol for Rs.100/- and one person informed him that he will pay through QR Code scanner and took photo of scanner and forwarded to someone through Whatsapp and informed to serve petrol, but the complainant informed him that after paying amount of Rs.100/- he will serve petrol. The person who was riding the said two wheeler vehicle moved a side and kept the engine in on position. Meanwhile another customer came for petrol and the complainant was serving petrol to him. The person who was standing adjacent to him snatched the cash approximately Rs.19,000/- from the complainant hand and ran away, meantime the person who was ready with two wheeler drove his vehicle towards Chaderghat. The complainant ran behind the person who took cash, but he escaped and sat on the two wheeler and fed away from there. Upon which Mirchowk Police registered a case and investigated into and as per the instructions of the superior officers formed two special teams to detect the case.

During the course of investigation crime team's verified more than 60 CCTVs in the entry and exit routes, analysed technical data and came to know that A1 to A3 committed the offence. A1 to A3 are friends and leaving in same locality, all are in financial crisis and are in need of money. A1 to A3 planned to commit theft from cashiers at petrol pumps in Hyderabad city. According to their plan on 17-04-2025 at about 06.30 hours the A1 to A3 started from A1's house on A2's Honda Twister vehicle by deliberately removing the number plate of the said vehicle bearing no.AP29AN4441. Initially they moved to the petrol pumps situated at Jummerath Bazar via, Chowk Hussaini Alam from there Nampally, Assembly, Tankbund, Ranigunj, Paradise and again Tankbund, Liberty, Kingkoti, Women's College Koti, watching the Petrol Pumps and they tried to execute their plan but they didn't attempt as there were more customers at the said petrol pumps. At last they came to Chaderghat and reached BPCL Petrol Pump, Kalikabar, Hyderabad and saw that there are few customers at the said petrol pump. In a far distance A3 got down from the said vehicle before reaching the said petrol pump and he was waiting at Chaderghat circle. Later A1 and A2 went to BPCL Petrol Pump,

Kalikabar, Hyderabad, A1 got down and informed the complainant to serve petrol for Rs.100/-. Meantime A2 took his vehicle a side and kept the engine in on position. A1 was waiting beside complainant and pretending like he is going to pay through Phonepay with the cell phone of A2. The complainant was busy with the customer in serving petrol and A1 took chance and snatched the cash from the complainant/cashier's hand and fed away from there. A2 drove his vehicle and fed away after going some distance he was waiting for A1, the complainant/cashier chased A1 but he escaped and ran towards A2 and fed away from there on the way A3 was picked up at Chaderghat circle. A1 to A3 fed away from there and reached A1's house and checked the cash and it was cash of Rs.19,000/-. Further all together spent Rs. 2,000/- for their food and for the bike, the remaining amount was shared among them i.e., A1 Rs.8,000/-, A2 Rs.6,000/- and A3 Rs.3,000/-. After committing the offence again they tried to commit similar offences at Petrol Pumps located at Kothapet, Poolbagh, Tadbun, Bahadurpura but they could not succeed. All petrol pump managements are hereby advised to be vigilant and cautious while handling the cash.

### Apprehension and arrest of the accused persons:

On 24-04-2025 at about 17.00 hours at Bibi Bazar X Roads, A1 to A3 were apprehended during the vehicle checking and they were arrested at 19.00 hours.

In a major breakthrough, Begumpet Police apprehended a notorious chain snatcher, Papani Kranthi Kumar. The arrest followed intensive surveillance and investigation, including the analysis of over 300 CCTV cameras, putting an end to a series of thefts across Hyderabad and Tirupati.

### **DETAILS OF THE ACCUSED PERSONS:**

**1.** Papani Kranthi Kumar S/o Late Srinivasulu, Age: 32 years, R/o: Madhura Nagar, Thirupathi, Andhra Pradesh.

#### CASES: -

**Begumpet PS (Crime No. 152/2025):** On 17.04.2025, a gold chain (approx. 2 Tulas) was snatched from a 75-year-old woman while she was asleep in her home.

**Marredpally PS (Crime No. 74/2025):** On 19.04.2025, the accused deceived a 75-year-old woman under the guise of enquiring about a shop for rent and snatched gold ornaments (5 Tulas) from her neck.

**Chikkadpally PS (Crime No. 109/2025):** On 16.04.2025, the accused stole a two-wheeler (Honda CB Shine) parked outside an apartment in Vivek Nagar.

#### **Investigation Highlights:**

Over 300 CCTV footages from various locations were analyzed to track the accused. Multiple police teams were deployed, and sustained surveillance efforts led to locating the suspect.

#### **Recovered Property:**

Gold Chain (59 grams) – Related to Marredpally PS Pearl Necklace (16 grams) – Related to Marredpally PS Gold Chain (19 grams) – Related to Begumpet PS Stolen Honda CB Shine Motorcycle (Br. No. TS09EF6828) – Related to Chikkadpally PS

Total gold recovered: approx. 9.4 Tulas worth Rs. 8.00 Lakhs

#### Modus Operandi:

The accused targets elderly women, choosing homes with open doors or using deceptive tactics like pretending to seek rental spaces. He takes advantage of moments when the victims were alone.

#### Criminal History:

Papani Kranthi Kumar is a \*habitual offender with a history of over 14 cases involving theft, housebreaking, and narcotics spread across Hyderabad and multiple police stations in Tirupati District. Financial stress caused by gambling and personal debts drove him to commit these crimes.

#### Investigation Team:

DI Begumpet and DI Gopalapuram along with their team under the supervision of ACP Begumpet and SHO Begumpet successfully apprehended

the accused following an extensive investigation which involved verification and analysis of large amount of CCTV footages and technical information.

The Hyderabad City Police continues to remain vigilant and proactive in its efforts to protect citizens, particularly vulnerable sections of society. Citizens are urged to stay alert and immediately report any suspicious activity to their nearest police station.

On credible information conducted raid, apprehended accused person, rescued victim and seized material.
