## **PRESS NOTE**

The Hyderabad City Police was reorganised after a gap of 35 years vide G.O.Ms.32, Home Legal Dept Dt.30.04.2023. The major highlights of that G.O. was the creation of 2 additional L&O Zones – South East + South West, 11 new L&O Divisions, 1 Additional Traffic Zone (Traffic 3), 11 more L&O police stations (total 71), 13 more Traffic Police Stations (Total 31), a Women Safety Wing with 7 Women Police Stations in 7 Zones, separate Cyber Crime Unit, IT Wing, Narcotics Wing. An extra strength of 1200 was sanctioned for these above changes.

Over the past 2 years, a few complaints have been received from the public regarding minor jurisdictional issues, inconvenience in travelling to their new police stations etc. Officers of the department have also given feedback about some issues, like confusion in Traffic and L&O police in some areas over jurisdictions, the need to strengthen Cyber Crime Wing more, weakening of cat.C L&O Police Stations etc.

In light of this, detailed consultations have been held with all stakeholders – public, public representatives, HCP officers of all ranks - and the following modifications in the G.O.Ms. 32, Home Legal Dept Dt.30.04.2023 were proposed to Govt., with only internal readjustment and reallocation of the entire HCP sanctioned strength of 17,020, without a single paisa financial burden to the Government. The TG Government has approved the proposed readjustments vide G.O.No.57, Home Legal Dept Dt. 24.04.2025. It is expected that these changes will stand the Hyderabad City Police in good stead for the next decade.

### **Major Changes Introduced:**

1. Creation of New L&O Police Station:

A new L&O Police Station - Tolichowki Police Station - has been established, marking the 72<sup>nd</sup> L&O Police Station under Hyderabad City Police. Select areas previously falling under the jurisdictions of Filmnagar PS, Mehdipatnam PS (formerly Humayun Nagar PS), and Golconda PS have now been brought under the newly established Tolichowki Police Station.

2. Renaming of Divisions and Police Stations with popular names :

To ensure better public identification 1 L&O division and 3 L&O police stations have been renamed to reflect their popular local references:

1. Golconda Division is now Tolichowki Division
2. Secretariat PS renamed as Lake PS
3. Humayun Nagar PS renamed as Mehdipatnam PS
4. Shahinayathgunj PS renamed as Goshamahhal PS

3. Restructuring and Renaming of traffic police stations to align their jurisdictions and names with the L&O Division. (as has been the historic practice)

The 3 existing Traffic Police Stations — **Marredpally, Bowenpally, and Narayanguda** — have been discontinued to bring the Traffic Police stations jurisdictions in accordance with the 28 L&O divisions. The existing Tr.

Nampally PS, Tr. Amberpet PS, Tr. Langer House PS, Tr. Bhahadurpura PS, Tr. Nallakunta PSs are re-named as Tr. Gandhi Nagar PS, Tr. Osmania University PS, Tr. Kulsumpura PS, Tr. Chatrinaka PS and Tr. Saidabad PS respectively and they will function within the areas of jurisdiction of respective Traffic Police Stations.

4. Creation of Specialized Units

Women Safety Wing (WSW) has been strengthened through the creation of dedicated units: Anti-Human Trafficking Unit (AHTU) – total staff 8 to be headed by 1 Inspector, Juvenile Bureau Unit – total staff 7 to be headed by 1 Inspector.

5. Zonal Cyber Crime Cells (ZCCs) have been established in each L&O Zone, staffed with 1 Sub-Inspector and 5 Police Constables per zone.
6. Strengthening of both L&O and Traffic wings sanctioned strengths to meet present and future policing needs with addition of 327 and 321 extra staff and officers.

### SPECIAL ZONAL CRIME TEAM, CCS, HYDERABAD NABBED THREE PERSONS WHO WERE IN ILLEGAL POSSESSION OF GANJA AND SELLING TO NEEDY PERSONS

On 29-04-2025 from credible information Special Zonal Crime Team, CCS, DD, Hyderabad nabbed three persons

1) Mohd Omer S/o Ghulam Mohd Age: 21 yrs, Occ: Cook(helper) R/o Talabkatta, Bhavani Nagar, Hyderabad

2) Mohd Ghouse Hussain S/o Mohd Rasheed Hussain Age: 47 years, Occ: Auto driver, R/o Talabkatta, Bhavani Nagar, Hyderabad and

3) Mohd Sohail S/o Mohd Nazeer Age: 20 yrs, R/o Talabkatta, Bhavani Nagar, Hyderabad N/o Zaheerabad

The above persons were trying to sell ganja to needy customers and recovered the following property from them which are as follows :

**1) Dry Ganja - 24 Kgs**

**2) Cell Phones - 03**

After conducting enquiry, handed over the above accused persons along with recovered property to Bhavani Nagar PS on which a case was registered vide Cr.No : 80/2025 U/s 8(c) r/w 20(b)(ii)(B) NDPS Act of Bhavani Nagar PS. Other accused namely Sona Jaweed and Faisal who were also involved in this case are absconding.

A case of "BRUTAL MURDER" that occurred on 28.04.2025 On the terrace of the Building bearing H.no 1-6-212/21, Kamala Nehru Nagar, Parsigutta, Secunderabad which reported on the same day at 05:45 hrs committed by the accused namely John Anil Lazarus@ Dhada S/o J.D Anil kumar ,Age:45 yrs, Occ: Recovery agent, R/o h no: 1-9-278/49/A/1/1/4, Balajinagar, Adikmet, Ramnagar, Hyderabad, who is the brother in law of the deceased has in a prepared manner killed him with a Iron Rod (Bike Protection Rod).

**FINDINGS IN INVESTIGATION:**

The accused person is the brother in law of the deceased and he is eddicted to alchol and used to petty works and eeking livelihood. On 27.04.2025 the deceased went MNR BAR Parking place where he met with one Rahulk who is the friend of the deceased and consumed alcohol with him and quarreled with him. meantime the accused person went there and tried to stop him. but the decased person attacked the accused person on that they left from there. After that in the eveing hours the acused person went to consume alcohol at parsigutta the deceased person again went to the accused and abused him and assaulted him, and threatened him by saying that he will kill the accused person and his family members. On that the accused person bore grudge on him and thought of kill the deceased, to execute the same the accused person went to the house and brought one Iron rod i.e. his Suzuki bike protection rod which was kept at his house and placed the at the tereace of the building at ICICI Bank ATM where the deceased used to sleep. After that the accused called to the deceased over phone and asked to come to parsigutta to consume alcohol. On that the deceased went to parsigutta to consume alcohol with the accused person at that time the two of their friends came there on that the accused person asked one of them to bring quarter and water bottle and two glass to consume alcohol and one of them did not consume alcohol and at about 21.00 hours their two friend left from there and the deceased went to sleep at the terrace of the ICICI Bank ATM building to sleep at about 21.00 hours. Meantime the accused person waited near the building for the accused to sleep. At about 21.14 hours the accused person went to the terrace of the building at ICICI Bank ATM and saw that the deceased was in deep sleep. The accused person thought it was the right time to attack to execute the same the accused had taken the Iron rod which he had placed on the tereace of the same building.

On 30.04.2025 at 07.30 hrs when the accused person was going to his house the police Warasiguda apperhanded him and brought to police station on which he admitted his guilt in the commission of the offence. After recording the confession statement of the accused person and followed by seizure report the accused person produced before the Hon'ble court for Judicial remand.
