# {{ Construction of New Osmania Hospital Building at Goshamahal Police Stadium – Inspection of Works and Relocation of Police Units}}

Hyderabad: The government has decided to construct a new building for Osmania Hospital within the premises of the Goshamahal Police Stadium. Today, Hyderabad Police Commissioner Sri C.V. Anand IPS inspected the ongoing construction works at the site.

Speaking to the media, Sri CV Anand stated that with the new Osmania Hospital building under construction, the police department's existing blocks are being relocated. He informed that the horse ground and stables have been temporarily moved to the vacant space within the Goshamahal Police Stadium. He added that, effective today, all departments belonging to the police force will be fully shifted and handed over to the Medical Department.

The Commissioner explained that the government has allocated 11.5 acres to the Hyderabad City Police at this location. Two five-storey buildings are currently under construction: one will serve as a suitable facility for the City Security Wing (CSW), and the other will be designed for parking various vehicles seized across the city's seven zones. Additionally, a new horse stable and ground are being prepared. He also mentioned that the government has allocated another 2 acres adjacent to the Traffic Training Institute (TTI). Chief Minister Sri A. Revanth Reddy has personally sanctioned Rs. 55 crores for these constructions. It has been decided that the Police Housing Corporation will complete the construction of these buildings in approximately one year.

### Formation of "Swift Women Action Team"

Sri C.V. Anand IPS DG CP Hyderabad noted that dharnas, rallies, and protests are frequent occurrences in Hyderabad city, and arresting women during such events has often presented challenges. To overcome this, a team of 35 newly recruited women constables has been formed at the Hyderabad Police Headquarters. This team has been officially named the "Swift Women Action Team."

The Commissioner elaborated that these women have received specialized training in karate over the past few days, along with specific instruction on how to safely detain and manage women during protests. Sri C.V. Anand IPS, CP Hyderabad, stated that more personnel will be recruited soon, and the team will be expanded into two platoons, comprising a total of 42 members. He extended his congratulations to the officers and all team members who have meticulously prepared the Swift Women Action Team.

## BUSTED ILLEGALL SALE OF AUDULTERATED GINGER GARLIC PASTE- APPREHENDED (01) PERSON

The sleuths of Task Force, South-East Zone team along with staff of Bandlaguda PS on credible information conducted a raid on Ginger & Garlic Paste Manufacturing unit (FK Food Product), Patel Nagar, Bandlaguda, Hyderabad where storing and selling adulterated Ginger Garlic Paste to needy customers, and seized large quantity of the adulterated paste, along with seizure of 4 kgs of Titanium Dioxide and 16 kgs of Mono Citrate, and apprehended (01) accused person.

### DETAILS OF APPREHENDED ACCUSED PERSON:-

Mohammed Faisal @ Faisal , Age 44 years, Occ: Business, R/o Patel Nagar, Bandlaguda Hyderabad.

#### SEIZED MATERIAL:-

- 1) Adulterated Ginger Garlic Paste- 870 Kg's
- 2) Titanium Dioxide- 4 kg's
- 3) Mono Citrate- 16kg's
- 4) 4kg turmeric powder for colouring

All worth of Rs. 1, 40,000/-

#### **BRIEF FACTS OF THE CASE:**

It has come to notice that Mr. Mohammed Faisal is engaged in the manufacturing of adulterated and noxious ginger-garlic paste at his residence, operating under the brand name FK Food Product. He is reportedly supplying this adulterated product to various general kirana stores and directly to known and needy customers. The said product is prepared using harmful chemicals such as Titanium Dioxide, turmeric powder for colouring and other chemical substance which are not permitted for such food preparations as per the Food Safety and Standards Authority of India (FSSAI) guidelines. These substances pose serious health risks to consumers and are a violation of food safety regulations. By adulterating the gingergarlic paste with these hazardous components, Mr. Faisal is endangering public health and engaging in illegal activities for personal gain.

The raid was made under the supervision of Sri S. Saidababu, Inspector of Police, South-East Zone Task Force team by SI's, Sri, Sk. Kaviuddin, P. Sairam, M. Madhu and PC Sri B. Shiva Lingam and the staff of Commissioner's Task Force, South-East Zone Hyderabad along with staff of Bandlaguda Police Station.

# ARREST OF GOLD CHAIN SNATCHER OFFENDER AND RECOVERED GOLD CHAIN Wg. 14 GRAMS FROM POSESSION OF ACCUSED.

Arrested the accused **Mohd Najeeb** S/o. Mohd. Jeelani, age: 35 Yrs, Occ: Lab Technician, R/o H.No: 13-1-1234/22/8, Sarwar Nagar, Asif Nagar, Jirrah, Hyderabad. In Cr.No. 164/2025 U/Sec. 304 (2) BNS & 307 BNS o PS Mehdipatnam, Hyd and being sent to the Judicial remand.

#### RECOVERED: 14 GRAMS GOLD CHAIN.

The sleuths of crime staff of Mehdipatnam Police Station apprehended the Chain Snatcher on 03.06.2025 at 10.30 hrs and recovered gold chain wg. about 15 grams from his possession while he was trying to sell them at Mallepally X roads, Hyd.

The brief facts of the case are that on 01.06.2025 at 11:00 Hours received a complaint from Smt. G. Chandrakala, W/o G. Sayanna (late), Age: 65 years, Occ. Housewife, R/o H. No. 39/2RT, Vijay Nagar Colony, Hyderabad. Ph.No: 8143737915, in which she stated that on 01.06.2025 early morning she went to buy milk packets at a Kirana shop nearby her residence and while returning to her home when she was at opposite to H.No: 7/2RT, V.N colony at about 07:20 hours one unknown person who was wearing a helmet came from backside and asked her in Telugu "Vijay Nagar colony idena?" and then suddenly he tried to snatch her gold chain which is about 2 tulas (20 grams) from her neck. While she was struggling to save her gold chain from his clutches, she caught her gold chain tightly with her both hands. Meanwhile he pushed her down but she did not let go her hands on her gold chain. Then he forcefully pulled it, upon which her gold chain broken into two pieces. One piece about 6 grams was in her hand and the remaining about 14 grams gold chain was forcefully snatched by him and he fled away from there. Hence, she requested to take necessary legal action as per law and do needful.

During the course of investigation, The IO examined the witnesses and collected documentary evidence such as ROC of Urban Market, Bank Statements of the Accused and Complainant and also victims, and after proper analysis with the C.A., it is revealed the complicity of the complainant Amit Kumar Pilania in this case and he is also an Accused.

While the efforts are on foot, on receiving credible information on 30.05.2025, a special team apprehended the prime accused A-1 Mukesh Chowdhary S/o Hawa Singh Chowdary, age: 33 years, Occ: Business M/s. Urban Market (Online Grocery app) situated at Chaitanyapuri, R/o H. No. 16-2-147/40, Anand Nagar, Malakpet, Hyderabad, also R/o Hari Nagar Colony, Backside Pattack School, Pilani, Jhunjhunu district, Rajasthan and basing on his confession, apprehended also A-2) Amit Kumar Pilania S/o Ranbir Singh, age 31 years, Occ: Business-M/s. Pilania Road Carriers, R/o A-805, 8th floor, Parvasaakshi Society, Pimple Saudagar, Pune City, Maharastra State., while they are available at Malakpet. Further, they are remanded to judicial custody on 31.05.2025. The investigation is still under progress, several witnesses are to be identified and some more to be examined and further efforts are to be continued to verify the complicity of others either victims or Accused

adequate parking facilities for them. He urged the preservation of old (historically significant)

structures in Hyderabad for future generations.

The Commissioner also informed that the Commissioner's office in Purani Haveli, belonging to

the Hyderabad City Police, has been undergoing renovations for the past three years and is also

nearing its inauguration. He added that once the Purani Haveli Commissioner's office is

operational, he would discharge his duties from there every Friday.
