

## PRESS NOTE

Hyderabad, June 24, 2025 – A crucial high-level coordination meeting was held today to finalize arrangements for Muharram in Hyderabad. The meeting, chaired by Sri C.V. Anand IPS, DG and Commissioner of Police, Hyderabad, brought together Shia community religious leaders, other community members, and officials from various government departments.

During Muharram, particularly on the 10th day of Ashura, Shia Muslims observe mourning to commemorate the martyrdom of Imam Hussain and his followers. This observance includes a large mourning procession (Matam), with thousands of Shia Muslims participating. This year, Muharram is expected to fall on July 6 or 7, 2025, depending on the crescent moon sighting. The procession traditionally begins at Bibi-ka-Alam, Dabeerpura, and proceeds through Ettebar Chowk, Kotla Aliza, Panjesha, Miralam Mandi, Charminar-Gulzar House, Purani Haveli, Darulshifa, concluding at Masjid-e-Ilahi, Chaderghat.

The Meeting Held at the Salarjung Museum, the meeting included comprehensive reviews of security, traffic management, and other essential arrangements. Officials from departments such as GHMC, R&B, Waterworks, Electricity, Medical & Health, Fire Services, Nehru Zoological Park, and the Telangana Waqf Board provided their insights and feedback.

Sri C.V. Anand IPS emphasized that the Police Department, in close coordination with all other departments, has taken proactive measures to ensure the Muharram Bibi-ka-Alam procession is conducted peacefully. He assured that sufficient vehicle parking facilities and traffic diversion plans would be implemented to prevent any inconvenience for participants. He also detailed the deployment of All Police Stations crime teams, police platoons, and She Teams to maintain order and deter any untoward incidents, particularly eve-teasing. Drawing from past experiences, the Commissioner affirmed that all efforts are being made to prevent any issues this year. He also pledged that concerns raised by community members during the meeting would be addressed in coordination with relevant departmental officers.

Regarding the elephant that participates in the procession, the Commissioner advised that it should be brought 2-3 days prior to the event to ensure it is well-rested. He stressed the importance of maintaining a safe perimeter around the elephant during the procession, ensuring people do not approach it too closely. Organizers were also advised to have a veterinarian and tranquilizer readily available to handle any unforeseen circumstances.

Senior officers from the Traffic Department will be on-site to closely monitor the traffic diversion plan and the procession's movement. Additionally, senior officials will oversee the procession at the ground level, with the entire route being continuously monitored via CCTV cameras from the Command Control Centre, TGICCC, Banjara Hills, in coordination with all departmental officers.

MARKET POLICE apprehended 18 members of a dacoit gang

AND RECOVERED around ₹ 43 LAKHS CASH

& about 59 grams of gold.

### FACT OF THE CASE:

Market Police have registered a case based on a dacoity complaint filed by Sri Hariram, resident of Bowenpally. The complainant reported that a known person, Radheshyam, offered him a deal for purchasing 1 KG of gold at a 5% discount on the market rate, on the condition of payment in liquid cash. Initially, the complainant was introduced to a group of five unknown persons. Later, Radheshyam and Rambabu visited the complainant's office to verify the availability of the liquid cash and confirmed the same to their associates over the phone. Subsequently, four unknown individuals entered the premises, posing as officials from the SOT Rachakonda Commissionerate. One among them identified himself as Keshavulu and displayed ID card. These individuals then assaulted the complainant and took away bag along with the mobile phones of the complainant, Rambabu, and Radheshyam, while issuing threats. They fled the scene using a car and two bikes.

#### MODUS OPERANDI:

A-1 and A-2, who are brothers, devised a plan to impersonate gold traders offering gold at a 5% discounted rate to lure victims with large amounts of liquid cash. Their actual intent was to stage a robbery during the transaction. A-2 contacted A-3 Suresh, who claimed to have connections in Pot Market. Upon Suresh's confirmation, A-1 and A-2 decided to go ahead. A meeting was held at Blue Sea Hotel on 18.06.2025 with members A-1 to A-15 to finalize the plan. Later, A-2 and others met the complainant and convinced him of the legitimacy of the gold deal. A-15 even showed an online account balance to build trust. Subsequently, Rambabu and the complainant went to his office to verify the cash, and the location was shared with the robbers. Following the plan, A-5 (Keshavulu) along with A-6, A-7, and A-8 arrived at the location posing as police officers, seized the cash and mobile phones, and fled. While escaping, Keshavulu handed over the cash to Rambabu, who then left on a bike with Bhanu (A-10).

During their escape, four individuals from a separate "Vehicle Recovery Team" (A-19 to A-22) who recognized Bhanu's bike as an EMI default vehicle intercepted them at Trimulgherry, searched the bag, found the cash, and robbed it under threat of false police

action. After learning about this incident, A-1 confronted Bhanu and others. A-13, Venkatesh, then summoned local associates who detained and assaulted Bhanu and others at Ghatkesar.

#### INVESTIGATION PROGRESS:

Through the examination of over 100 CCTV cameras and witness statements credible information, the investigation revealed the involvement of two distinct criminal groups:

The original dacoity gang who executed the fake gold deal and robbed the complainant.

A secondary group reportedly a vehicle seizure team, who robbed the original robbers.

#### SUPERVISION:
