Telangana Anti-Narcotics Bureau Observes World Drug Day with State-Wide Awareness Campaign

Hyderabad, June 25, 2025 – The Telangana Anti-Narcotics Bureau (TGANB) has launched a comprehensive State-wide Action Plan to observe the **International Day Against Drug Abuse and Illicit Trafficking (World Drug Day)** on June 26th. IS SADAN POLICE AND SOUTH-EAST TASK FORCE- NABBED ONE GANJA PEDDLER - SEIZED 45 KGS OF GANJA, WORTH OF RS. 11,25,000/-.

On 25-06-2025 at about 10.00 hours, on a tip of information the sleuths of IS Sadan Police Station along with the staff of Commissioner's Task Force, South-East Zone team, Hyderabad intercepted one Hyundai Verna Car at IS Sadan X Road, Hyderabad and apprehended one Ganja peddler by name Janapala Harikrishna @ Janapala Harikishan who is in possession of contraband i.e. Dry Ganja and seized 45 Kgs of Dry Ganja.

DETAILS OF THE PEDDLER:

Janapala Harikrishna @ Janapala Harikishan, S/o Janapala Narsaiah, Age 28 years, Occ: Car Driver, Caste: SC-Madiga, R/o H.No. 1-112/1, Peddakandukur, Yadagirigutta(M), Yadadri (D) # 9676969412, 9618489878.

BRIEF FACTS OF THE CASE:

On 25-06-2025 at about 10.00 hours, on a tip of information the sleuths of IS Sadan Police along with staff of Commissioner's Task Force, South-East Zone team, Hyderabad intercepted one Hyundai Verna Car at IS Sadan X Road, Hyderabad under the limits of IS Sadan PS and apprehended one Ganja peddler by name Janapala Harikrishna @ Janapala Harikishan who is in possession of 45 Kgs of contraband i.e. Dry Ganja. On enquiry, it is revealed that, he is a native of Peddakandukur, Yadagirigutta (M), Yadadri District, and working as a cab driver. He purchased a second-hand Hyundai Verna car and has been using it for cab driving. He developed an acquaintance with one Thunam Aravind, a resident of Ambedkar Colony, Mahabubabad District, who is his childhood friend and also ganja peddler. Thunam Aravind informed him that they could make huge profits by engaging in ganja transportation. Following Aravind's instructions, Janapala Harikrishna went to Mahabubabad, and from there, both of them travelled to Kalimela, Odisha in Harikrishna's Hyundai Verna car. There, they met one Sarath Kumar Sahu, R/oBatagaon, Sambalpur, Odisha, and purchased approximately 45 kilograms of ganja. They returned to Mahabubabad with the consignment. After returning, they waited for two days to find

a buyer but were unsuccessful. Subsequently, Thunam Aravind instructed Harikrishna to store the ganja at his house in Peddakandukur, Yadagirigutta (M), Yadadri District until a buyer was found. On 25-06-2025, Thunam Aravind directed Janapala Harikrishna to transport the ganja to the Mangalhat area of Hyderabad city for sale. While transporting the ganja to changed the regulapr route by following alternate route in his Hyundai Verna car from Peddakandukur, acting on a tip-off, the police intercepted the vehicle at IS Sadan X Road, Hyderabad under the jurisdiction of IS Sadan Police Station and apprehended him and seized ganja from his car.

In this case, another accused persons namely 1) Sarath Kumar Sahu R/o Batagoan, Sambhalpur, Odissa (Supplier) and 2) ThunamAravind R/o Ambedkar Colony, MahabubbadDist (Peddler) are yet to be apprehended.

PRESS NOTE ORGANIZED ONLINE SATTA BETTING RACKET BUSTED – 06 PERSONS APPREHENDED

The sleuths of the Commissioner's Task Force, Central Zone Team, in a joint operation with Amberpet Police Station, have successfully busted an organized online Satta betting racket. Acting on credible information, the team raided a rented flat located at Bathakammakunta, Bagh Amberpet, under the jurisdiction of Amberpet PS, and apprehended (06) individuals involved in the illegal activity. The accused created multiple fake Facebook IDs linked with unidentified mobile numbers to promote their illegal betting activities. Initially, they lured victims by offering small profits. As the victims invested larger amounts, they began to suffer losses due to the manipulative nature of the betting games.

> Case Details:

All six accused, being friends and natives of Kagaz Nagar, gained knowledge about online betting and Satta/Matka operations. In pursuit of easy money, they rented a flat in Bagh Amberpet two months ago for ₹14,000 per month and set up their base of operations using laptops and mobile phones.

They created several Face book accounts under names like Satta Matka Kalyan Result, Ashwin Nayak, Teer Shillong Counter, Arjuin Sarkar, and Vishal K, linking them to unverified phone numbers. They used these platforms to attract unsuspecting individuals who had a habit of participating in online international betting & Satta Mataka betting.

Each punter was asked to pay a registration fee ranging from ₹1,000 to ₹2,000 for number predictions in Satta betting. Additionally, the accused made fake promotional videos where one of them acted as a punter claiming to have won large

sums from small investments, thereby promoting the betting site and encouraging more victims to invest larger amounts.

The accused collected money through online payment modes including QR code scanners, Google Pay, PhonePe, and other UPI platforms. They manipulated the outcomes of the games hosted on their sites to ensure the victims ultimately lost their investments.

On the night of 24-06-2025, based on credible intelligence, the Commissioner's Task Force, Central Zone Team, along with Amberpet PS, apprehended the six accused and seized the aforementioned material. The arrested individuals and seized property have been handed over to the SHO, Amberpet Police Station, for further investigation.

The operation was led by the Inspector of Police, Task Force Central Zone, with the support of the Sub-Inspector and staff of Task Force Central Zone and staff of Amberpet Police Station.
