

**PD ACT INVOKED AGAINST MUVVA VEERAI AH CHOWDARY S/O M. HARI BABU
PROPERTY OFFENDER OF SANJEEV REDDY NAGAR POLICE STATION,
WEST ZONE, HYDERABAD**

Sri Anjani Kumar, IPS, Commissioner of Police, Hyderabad City invoked P.D.Act against Muvva Veeraiah Chowdary S/o M. Hari Babu, **Property Offender** of Sanjeev Reddy Nagar Police Station on 25.8.2018.

Muvva Veeraiah Chowdary S/o M. Hari Babu, aged about 33 years, Occ: Employee in SMS Pharma, Bollaram, R/o H.No.5-3-38, Damodar Building, BJP Office Lane, Kukatpally, Hyderabad, N/o H.No.3-38, Veerannapalem, Parchur, Prakasam Dist, Andhra Pradesh State has been committing offences of theft of cash from ATM centres under the guise of helping the customers and diverting their attention by exchanging the ATM Cards in the limits of Hyderabad and Warangal Police Commissionerates to make easy money and to lead a lavish life.

He committed **23 such offences** in the limits of Hyderabad and Warangal Police Commissionerates and has been creating fear and panic among the general public by committing such offences in public places and thus he has been acting in a manner prejudicial to the maintenance of public order apart from disturbing the peace, tranquillity and social harmony in the society.

Sanjeev Reddy Nagar Police made efforts to arrest the accused Muvva Veeraiah Chowdary on 30.10.2017 in Cr. No 758/2017 of Sanjeev Reddy Nagar Police Station and remanded to judicial custody. He was released on bail and again committed 12 more offences in Warangal District and other districts of Andhra Pradesh State. He was again arrested on 13.4.2018 in Cr.No. 23/2018 of Parchur PS, Prakasam District. The Detention Order was executed on him on 29.8.2018 in District Jail, Ongole, Prakasam District.

A MAN RAPES HIS OWN DAUGHTER TO FULFILL HIS SEXUAL DESIRE

Police Bowenpally nabbed an accused person by name **Mohammed Sameer s/o Md.Ahmed Sharief age 44 years Occ: spray painting work r/o H.No. 8-8-14/11 Dilkushnagar, IDPL, Balanagar Secunderabad, a habitual drunker**, raped his own daughter **Ayesha (Name Changed) aged about 11 yrs** in drunken condition at his house. Upon which a case in **Cr.no. 295/2018, U/s 376(2)(f), 376(3) of IPC and Section 5(m) & (n) r/w 6 of POCSO Act 2012 of PS Bowenpally** and the accused person is arrested on 29-08-2018 by Bowenpally Police, Secunderabad.

Brief facts of the case are that on 27.08.2018 at 21.00 hrs received a complaint from Smt Faimeeda Begum w/o Mohd Sammer age: 35 years, R/o Dilkushnagar, IDPL, Bowenpally, Secunderabad, stating that she is residing in the above mentioned address since 20 years. She got married with Mohd Sameer, 13 years ago and blessed with two children namely 1. **Ayesha (Name Changed), age: 11 years**, and 2. Mohd. Ghouse, age: 8 years. Since her marriage her husband is a regular habitually drunker and also harassing character. On 23.08.2018 her daughter was suffering with fever, at about 1700 hrs she along with her younger son went to market to purchase some fruits. On reaching market she found her husband, which he was already purchased fruits and on seeing, she said to her husband to go to home and give it to her daughter and she will bring the Panipuri to her. At about 18.00 hrs she returned to home and found her husband laid on her daughter in obscene gesture mode and they both don't have cloth on their body. On seeing that, she forcibly pushed her husband from her daughter. On enquiry with her daughter **Ayesha (Name Changed)**, she came to know that her husband removed her daughter cloths forcibly and he also removed his cloth and threatened her to kill her if she informs the same to anyone. Then forcibly he laid on her and started kissing and also gave mouth to mouth kisses and bitten on her chest, during this she tried to push him from her, but due to his heavy body she was unable to do that. When she tried to shout he shut her mouth and sexual assaulted her. She further stated that her husband also previously involved in a case Cr.No.426/2010 U/s 376,109 IPC of Jeedimetla Police Station and went to jail for that, but still he has not changed his behavior. Thinking of women's dignity and pride she did not give the complaint early, but later on thinking of past history of her husband she stepped forward to give complaint against her husband Mohd Sameer. Hence she requested to take necessary action against her husband.

The investigation revealed that, the accused **Mohammed Sameer s/o Md.Ahmed Sharief age 44 years Occ: spray painting work r/o H.No. 8-8-14/11 Dilkushnagar, IDPL, Balanagar Secunderabad.**, is a womanizer and having sturdy sex desire and had a bad eye on his daughter, who is a school dropout and staying in home and assisting her mother. The accused raped his own daughter to fulfill his desire. Earlier, he was arrested by Jeedimetla Police in **Cr.No.426/2010 U/S 376 IPC of Jeedimetla PS** for raping his Co- Worker. and been to judicial custody.
